Position: Tenure track, Rank of Assistance Professor, Nurse Practitioner and/ or Clinical Nurse Specialist (4 Positions)

Minimum Qualifications: An earned doctorate in an allied field with a Master's Degree in nursing, or a Doctorate in Nursing with any clinical major or area of concentration with a specialization in any of the following clinical areas: Adult/Gerontology, Community Health, Adult/Family/Geriatric Nurse Practitioner, Medical Surgical Nursing, Critical Care Nursing, Obstetrics/ Women's Health Care, Pediatric Nursing, Psychiatric/Mental Health. Potential candidates may also have specialization in content areas such as cultural anthropology, nursing administration or education, psychosocial nursing, pathophysiology, pharmacology. Potential candidates who have completed all their doctoral course work and are in process of completing their dissertation will be considered. The candidate must be prepared as an advanced practice nurse with recent experience in a clinical setting (within the last five years) as relevant for potential position. The candidate must be eligible for licensure as a registered nurse in California and eligible for National and/or State Certification as appropriate to clinical or functional area. Ability to communicate and work effectively with an ethnically and culturally diverse campus community. Potential for or record of scholarly/ creative activity. Demonstrated teaching experience as a nursing educator in didactic or clinical courses in a postsecondary nursing program.

Desired/ Preferred qualifications: Record of research, publication, other scholarly, creative, and community activity. Ability to teach a variety of theory and clinical courses. Ability to work in a team- teaching, collegial relationship. Current knowledge of clinical practice issues. Previous experience in curriculum development, long distance instructional delivery and/or web- based instructional methods. Previous experience in nursing leadership or management position. Success in obtaining external funding through grants and contracts adds strength to the candidacy. Ability to teach in more than one clinical area. Doctorate in nursing, Ph. D, or Ed. D. in a related discipline from an accredited institution.

Duties: Select, teach, evaluate courses content; teach didactic and student clinical courses at the undergraduate and/ or graduate level. Participate in student recruitment and retention, advise Nursing majors, serve as a member of thesis and comprehensive examination committees; serve on Department, College and University committees. Serve as a liaison between clinical agency personnel and the Department of Nursing. Maintain ongoing program of scholarship leading to publication.

Salary: Commensurate with experience

Required documentation: Letter of application addressing qualifications, professional resume (include e-mail address), three recent letters of recommendations (one attesting to teaching effectiveness), student evaluations and official transcripts from institution awarding highest degree (at the time appointment) and the Master's in Nursing Degree.
