### **DOCUMENTATION OF FINANCIAL SUPPORT**

In order for CIE to be able to issue you a new I-20, we must verify that you have provided us with updated documentation of financial support.

- If you will use your personal funds as the source of financial support, you must provide us with a copy of your bank statement showing the availability of at least **\$32,211 (undergraduates) or \$30,885 (graduates)**.  
**Bank statements can be no older than 6 months.**
- If you will be supported by a private sponsor (family member, friend, private institution...), the sponsor must either complete and sign the Statement of Financial Obligation below or provide a letter declaring their relationship to you and their intent to provide financial support throughout your studies. In addition, sponsors must also provide an official bank statement showing the availability of at least **\$32,211 (undergraduates) or \$30,885 (graduates)** in liquid assets.  
**Bank statements can be no older than 6 months.**
- If you will be sponsored by a public agency (embassy, home government, public institution, religious organization...) the agency must provide updated certification that the appropriate costs will be covered if we do not already have a valid current certification.

(Family Members: Students who will be accompanied by a spouse and/or children will need to submit additional documentation of financial support (\$4,600 for spouse and \$3,800 for each child)
