CRITICAL THINKING VALUE RUBRIC

This rubric was developed by the AAC&U and is used here as a <u>sample</u> of how the learning objectives <u>might</u> be assessed. For more information on the development of the Essential Skills rubrics, please contact value@aacu.org.

While departments and programs should <u>NOT</u> alter <u>learning objectives</u>, *performance indicators* used to measure the learning objectives may be altered and can vary depending upon the course or program. **Departments will need to indicate the performance indicators used to measure each of the 2 -3 learning objective (per essential skill) assessed in their program reviews.**

Definition

Critical thinking is a habit of mind characterized by the comprehensive exploration of issues, ideas, artifacts, and events before accepting or formulating an opinion or conclusion.

Influence of context and assumptions	Thoroughly (systematically and methodically) analyzes own and others' assumptions and carefully evaluates the relevance of contexts when presenting a position. Conclusion is logically tied to a range of information, including opposing viewpoints; related outcomes (consequences and implications) are identified clearly.
