Description of the Signature Assignment

Candidates will be asked to develop a research proposal, including, research questions, literature review, and quantitative/qualitative methodology. Through this assignment, candidates will demonstrate their understanding of basic research skills and knowledge in designing educational research.

Directions for Students

The purpose of this assignment is for candidates to demonstrate their understanding of basic research skills and knowledge in writing a research plan. The plan must be typed, spell-checked, double-spaced with a standard 12-point font, and submitted in hard copy. References must be properly cited using the American Psychological Association (APA) format. The research plan should be in the following format:

Chapter I: Introduction

- 1. Introduction (1page)
 - a. Provide an overview of the broad problems in education that lead up to this particular study.
- 2. Purpose of the Study (1/2-1 page)
 - a. Describes what the study will do a direct response to what needs to be known.
 - b. The research questions are presented here.
- 3. Significance of the Study (1/2 page)
 - a. Describe what contribution to the broad literature or set of broad educational problems would be made when the study is finished.

Chapter II: Literature Review

- 1. Introduction (1/2 page)
 - a. Provide orientation to the purpose and topics of the chapter.
- 2. Synthesizing the literature (2 pages).
- 3. Conclusion (1/2 page)

Chapter III: Methodology

- 1. Introduction (1/2 page)
 - a. Review the purpose and research questions for the study.
- 2. Subjects (1/2 page)
 - a. Provide a detail description of the subjects
- 3. Instrumentation (1/2-1 page)
 - a. Relation of research questions to instruments.
 - b. Psychometric issues reliability and validity.
- 4. Procedure (1/2-1 page)
 - a. Provide a detail description of the data collection process.
- 5. Data Analysis (1/2 page).
