- 1. Call to order
  - \*UMGSSC Chair, Arturo Zavala, called the meeting to order at 10 AM.
- 2. Designate member to take minutes
  - \*Niloofar Bavarian volunteered to take minutes.
- 3. Approval of UMGSSC Meeting on March 12, 2018
  - \*Art made a motion to approve the minutes, and all in attendance agreed.
- 4. Election of the UMGSSC committee vice-chair
  - \*Art made a motion to approve Niloo as Vice-Chair, and all in attendance agreed.
- 5. Update the UMGSSC committee membership roster
  - \*All were asked to check the UMGSS Roster document to ensure accuracy.
- 6. Election of member to serve on the University of Awards Committee (UAC)
  - \*Ali notified the committee he is already on the UAC.
  - \*Art will check with Ann Kinsey (Academic Senate) to see if Ali can represent the UMGSSC
  - \*As a note, the current Vice Chair may serve on the UAC committee next year
- 7. Reassigned time for exceptional levels of service to students review process & timeline
  - \*Art sent out policy the policy for Reassigned Time for Exceptional Levels of Service via email

- -Art shared that these are merit-based awards, so they are not necessarily distributed evenly across colleges
- \*Art summarized what was done last year: ~60 applications were reviewed by 4 groups; rated on a 1-4 scale (4= highly recommended); of the 60, ~20 were funded
  - Last year, BeachBoard was used to review applications
  - We will have access to past applications to see successful past awards
- \*This year: Once applications are received in Spring, Art will work with Norbert to assign the review groups randomly; then the groups will meet electronically to rank applications; if all agree with final ranking, the recommendations will be given to the committee chair.
  - -Will have 2-3 weeks to review applicants (March to April);
  - -Each person usually has 10 applications to review

## 8. Mini-grant and summer stipend review process & timelines

- \*Mae shared that the Chancellor's Office has made ~\$200,000 in funding available for Minigrants and Summer Stipends
- \*Mae led us through the review procedures
- -Applications are due 11/9 (Mae estimated approximately 40-50 applications will be submitted)
  - -Applications are submitted through InfoReady (<a href="https://csulb.infoready4.com/">https://csulb.infoready4.com/</a>)
- -We will use the Review tab in InfoReady, and Mae will add us as Reviewers when all the applications are submitted; we will receive an e-mail with the list of applications we have been assigned to review
- -Prior to our review, the applications will go through the College Committee Review, the College Committee Chair and Dean Review; when we receive the reviews, we will see the previous comments; we agreed to reviewing the application in full, and not just the decisions made during the prior reviews
  - -Our reviews are completed based on 6 criteria
