Knowledge of exemplary science teaching practices and applicable science education research. Commitment to and/or expertise in educating a diverse student population.

Desired/Preferred Qualifications

Recent K-12 science teaching experience. Successful experience working with preservice teachers. Successful experience teaching and/or supervising preservice teachers. Prior experiences with demonstrated excellence in effective teaching.

Duties

Teach undergraduate and credential courses on a part-time basis. Primary responsibility includes teaching science education courses in elementary or secondary school teacher preparation. May also become involved in working with student teachers as a university supervisor.
