#### SPECIAL ORDERS

- 6.1 Report from CSULB President Jane Conoley, TIME CERTAIN 2:10 PM – JC reports on improvements made on campus to combat the extreme heat. She also discusses event involving Turning point USA presenters breaking campus rules. NS asks if Outpost is closing. JC answers 'no,' they had a water problem that has been repaired. N. Schürer asks about the gift card policy for students involved in research projects. He believes this policy is damaging to research projects and students who may or may not choose to participate in research due to confidentiality and financial aid issues. JC states they have been working on this and are petitioning the CO regarding this issue. E. Guzik asks if students will be required to receive COVID boosters. JC says this has not yet been discussed, and currently we do not require a second booster. She will get back to the Senate with any updates about COVID requirements. J. O'Brien asks about south campus food options in the evening. S. Apel says there is a food truck coming to campus near PH 1 from 5-9 pm. Several senators state that food trucks are expensive. S. Apel says the Beach Hut will be reopened in spring. The Nugget will reopen at some point as well, and the problem has been in hiring cooks. A. Nayak asks about SB 410. JC discusses the cost and impact on courses. JC notes that Gov. Newsom vetoed the bill.
- 6.2 Report from CSULB Senator to the Academic Senate of the CSU, Kelly Janousek KJ reports on ASCSU resolutions and voting that will take place in November, and she solicits feedback from senators as to how the state senators should vote. She goes over the resolutions that will be voted on at next ASCSU meeting.
- Discussion of AB 928 and CSU lower division GE curriculum with the transfer package (Cal-GETC) – KJ reports on AB 928, and notes that it has already passed in the legislature. She mentions the differences this will make in the GE pathway for transfer students. The Cal GETC plan cuts six units from the GE pathway. If ICAS cannot agree before 5-31-23 on the pathway, then the CO will decide. October 24, 2022 is the deadline for campus members to present feedback about this issue. Three choices have

been presented to CSU campuses: 1) Support the current proposal; 2) Recommend changes with rationales; or 3) Declare an impasse. PFH then presents slides explaining AB928 further. She shows slides with tables indicating the areas where the cuts in GE will occur – Area C, Arts and Humanities (one course, 3 units will be cut) and Area E Lifelong Learning (one course, 3 units will be cut). Campus senates are asked to review the chart and present feedback to the statewide senate. Discussion ensues and senators ask questions. PFH mentions again the feedback we can provide to the ASCSU: 1) support the ICAS Cal-GETC; 2) suggest changes; or 3) fail to come to a consensus. There will be a town hall next Thursday 10-6-22 from 2-4 pm via Zoom. The Zoom link to be provided on the senate website.

#### 7. NEW BUSINESS

Proposed revision of Export Control Policy (AS- 1186-22/URC) - Moved by M. Aliasgari, 7.1 and seconded. FIRST READING- TIME CERTAIN 3:00 PM - Simon Kim presents the Export Control Policy to the Senate. We had a routine audit from the CO last fall and they noticed we did not have a written policy on export controls. We need a campus specific policy in place. Jason Wang came up with a draft policy. Jade Sche presented the importance of this policy to Senate. An export is the shipment or transfer of controlled items, software, or data. The release or transmission of items, information, or technology subject to export control to a foreign national within the U.S. is also covered under this policy. Export regulations are reviewed by JS. Export rules are presented. Exclusions include university activities that are exempt from export controls. Fundamental research, educational information, and public domain information is exempt. The office of ORED manages this compliance on our campus. Other entities involved include export liaisons, business administrators, Pl's, ECC's, Environmental health and safety, human resources, and Office of International Education. The rollout of the communication plan is presented. The online training approach is presented, and this training will be no charge to those affiliated with our University. P. Soni offers his approval of this policy. Questions ensue. Moves to second reading at next AS meeting.
