6. SPECIAL ORDERS

6.1 Report from CSULB President Jane Conoley, TIME CERTAIN 2:10 PM – JC reports that COVID vaccination and booster numbers continue to improve. Mask message went out recently due to L.A. County recent change in masking regulations. She reminded us to continue to our daily pre-screen and present green check mark if asked. Board of Trustees is currently meeting to discuss the controversy surrounding the Chancellor. There was an incident on campus in which the police received a call of shots fired on upper campus. Upon investigation, it was balloons popping. Because it did not escalate to an actual "incident," it was not put forward on the Beach notification system, a tweet was sent out however. Some senators were concerned that they learned of it via a tweet rather than via email or other notification. EK suggested that faculty enthusiastically welcome students back to campus as she did.

- 6.2 Report from CFA Co-President, Deborah Hamm- DH reports that CFA has had a 95% approval vote for the tentative agreement. There were two salary increases approved as well as a PPI and a COVID service award. CFA was fighting for rights, respect and justice, and this agreement addressed these issues. For some of the items where they did not win in the agreement, they have implemented working groups to address: 1) develop better job security for contingent faculty, 2) more ways to support working parents, 3) and alternatives to police on our campuses and improved options for conflict mediation. March 9-12 will be an online Equity Conference 2022.
- 6.3 Report on January ASCSU meeting from ASCSU Senator Kelly Janousek- KJ reports on the highlights of the ASCSU session. There has been a revision of EO 1077 regarding admission to teach education, preliminary credential programs. Equity dashboard now exists to see teaching outcome to understanding learning gaps https://csusuccess.dashboards.calstate.edu/public/dashboard-index . Humboldt State is now Cal Poly Humboldt, they are becoming more of a technology campus. According to the Senate Census, LB is #1, 123.5 FTE, more than #2 Fullerton. The following resolutions have been passed: on teaching modalities; on Education generally such as establishing core competences; on a study on the impact online education and impact on campus initiatives; on Faculty issues; on faculty rights to due process; on recognition of faculty in RSCA and participation in shared governance; and on to update legislative advocacy policy. Forthcoming resolutions include long term adequate funding, pending tentative agreement between CSU and CFA, and review of fiscal impact of AS 927.
