5. CONSENT CALENDAR N/A

SPECIAL ORDERS

- Report from CSULB President Jane Conoley, TIME CERTAIN 2:10 PM JC reports on COVID. Numbers for staff have gone down, but students' numbers have gone up. Regarding masks, we are following the numbers in the community. The medical director feels that we are safer in classrooms with masks. JC mentions situation with UPD and Dr. Osuna, and we have updated the policy that will allow a picture from the website to be pulled out to authenticate identification. An oversight committee has been suggested, however there are legal issues with this as well as Union and oversight issues. The current Community Engagement Board will continue to meet and deal with issues regarding UPD. The practice of providing laptops to students who are in need is continuing. Budget news: Some pay increases will have to come from campus funds. We are down 1,000 students from last year, and this will affect the budget negatively. These students are mostly seniors. KJ commends JC for supporting an opposition to book banning. CW speaks on the current travel restrictions (AB 1887) which is currently at 23 states. This hurts research and student success due to lack of travel opportunity. JC says perhaps non-state funds can be identified for use in restricted travel. SA states "The travel restriction is not a CSU policy, but a CA DOJ policy." SD asks about plans for reopening food locations. JC notes that many closures are due to staffing shortages. The current locations are available at: https://www.csulb.edu/eat-and-shop. JC says the Nugget will be reopening in the near future. L. Nou suggests a survey asking how many professors have been locked out and how many have been negatively affected by the UPD policy. Some of the laptops are provided by HERFF funds, and some are from C-SUCCESS program. T. Ciborowski reports that students have shared concerns about the buses/shuttles on campus. PFH goes over information from the new Senator orientation for those who missed and where to access information regarding the various University committees and councils.
- Report from CFA Co-President, Deborah Hamm DH reports that the UPD situation regarding the policy has been resolved to a point, and the policy has been amended. DH shows her octopus slide and explains how the CFA supports faculty through various activities. DH mentions faculty raises and addresses situations with newly hired faculty, noting that CFA is working on this. The CFA is still unhappy with the CO over raises for campus presidents. The CFA will respond to this in October at the BOT meeting. DH ends her report with a reminder to get along and care for/about each other.
- 6.3 Report from CSULB Senator to the Academic Senate of the CSU, Kelly Janousek KJ reports on the last ASCSU meeting that took place May 18-20, 2022. KJ notes that the ASCSU assists faculty in matters of system-wide concerns, fiscal concerns, and academically related fiscal matters. The ASCSU has no authority to override campus policies. They have five subcommittees to create resolutions and policies. The ASCSU passed 20 resolutions in the May 2022 meetings. The resolutions passed included Curriculum, Facilities, Faculty, GE, Title IX, ASCSU procedures, and Controversial/Concern.

- 7.1 Review the Work Accomplished by AS in AY 21-22
- 7.2 AY 22-23 Academic Senate Meeting Modality PFH presents a slide with the current meeting modalities at other CSU's and discusses options. Discussion ensues on this topic.

- A vote is then conducted on meeting modality going forward this year. Vote results: FTF-21, HY-5, Zoom-28. **Zoom wins for Fall semester.** Will reevaluate in Spring.
- 7.3 Proposed revision of PARC charge (AS-1141-20/CEPC)—FIRST READING DP moves, seconded, and then DP presents the revised charge. JC mentions that this proposal brings the policy into alignment with our new strategic goals, as well as institutional and learning outcomes. It also brings assessment into current times by having the institutional assessment that the University is required to have. NS asks about representation of the various colleges. Steering committee changes are mentioned. Reassigned time is mentioned, and JC says the Provost is being contacted because this is a labor-intensive council. This will not be added to the charge. Moves to SECOND READING at next AS meeting.

- 7.5 Proposal for a new Bachelor of Science in Dance Science (AS-1170-22/CEPC/URC)—FIRST READING, TIME CERTAIN 3:40 PM Moved by J. Cormack, seconded, and presented. Guests: Betsy Cooper, Chair, Department of Dance; Brooke Winder, Program Director of Dance Science Option, Department of Dance; Colleen Dunagan, Acting Associate Dean, College of the Arts. COTA members present the new BS in Dance Science via PP, specifically BC, BW and CD. This will improve the health of dancers who are both artists and athletes. Discussion and questions ensue. Moves to SECOND READING at next AS meeting.
