Meeting 14 – AY2021-2022 Wednesday, May 11th , 2022 Meeting held online (Zoom)

- 1. Meeting called to order at 2:22pm
- 2. M/S/P Approval of agenda
- 3. M/S/P Approval of minutes from April 27th, 2022 meeting
- 4. Announcements from Chair Paskin:
 - a. The Academic Senate has approved our revisions on a number of policies, including Probation policy (converted our recommendations to Academic Warning 1 and Academic Warning 2).
- 5. M/S/P Approval of GE Supplement
- 6. New Proposed Policy on Credit for Prior Learning Second Reading
 - a. Chair Paskin reviews the changes made to this policy since the last meeting to align it with CEPC feedback.
 - b. Perrone comments on recognizing knowledge or skills gained in past experiences, in the Introduction.
 - c. Cooper comments on the specific recognition of military experiences as opposed to other specialized experiences (e.g., performance, business, etc.). Cormack notes that military is highlighted due to its presence in a later sub-section dedicated to military experience. Bentley and Green add clarifying comment.



- d. Chair Paskin will return to Line 31 to add a clarifying sentence regarding GE.
- e. Cormack and Green support retaining Lines 63-64 stating that faculty involved in experiential learning assessment will be provided training and development. Perrone and Joshee comment. Paskin asks if the training should be required. Ayala and Cormack speak in support of required training, Chesler offers comments. Paskin adds policy language specifying the requirement of faculty and staff evaluators to complete training and development for this purpose.
- f. Perrone and Joshee note the inconsistency between 1.3.1 and statements in the Introduction. Cormack notes that this section can be revised once later elements of the policy are clarified; Paskin agrees. Marayong comments on the same need for retrospective revision in section 1.3.2.
- g. Chesler asks about language in 1.4.1, Cormack and Green clarify that academic record should be replaced with "transcript". Joshee, Hsieh, Ayala, and Marayong comment as well. Paskin makes language edit to incorporate Hsieh's concern. Cormack, Joshee, Moushon, Hsieh, and Peronne reconcile the Chancellor Office articulation of 1.4.1 and 1.4.2 with that under discussion.
- h. Marayong suggests re-organizing text regarding maximum units that can be gained through this policy. Joshee notes that changes in other policies may mean this section must be revised; Cormack confirms.
- i. Perrone, Cormack, and Joshee recommend updating the policy to encompass Article 3 (CPL outside of traditional higher education) as distinct from Article 2 (see: <u>https://calstate.policystat.com/policy/9817841/latest/</u>). Paskin recommends an ad hoc committee will reconcile language in the CSU policy with the current one, over the summer.
