3. The committee agreed to remove the new language and implement the revisions next spring 2023 in order to communicate the changes to faculty who will be undergoing review.

4. Another update requests that faculty *"include references in an addendum (not included in the 3-page limit)"*. This is a clarification that faculty can include references/ citations without it counting towards the page limit.
