6. SPECIAL ORDERS

[Time Certain 2:10 pm] Report from CSULB President Jane Conoley – President J. Conoley is on a trip, so Provost KSG presents on behalf of J. Conoley. J. Conoley traveled to Washington D.C. to meet with many agencies and participate in congressional meetings. President I. Julian participated in this trip as well. Congressman Garcia has directed 3.5 million dollars for upgrades at Isabel Patterson Childcare. Over 10,000 graduates have registered to participate in commencement ceremonies. The CSULB team has worked with Puvunga tribes for stabilization of berms (deposited soil). There is opposition for using heavy machinery on the tribal soil, so removal of vegetation will be done by hand. Last Saturday, April 15, Day at the Beach was brought back: 11,500 admitted students and their families were on campus, as well as 100 volunteers. Resource tables were available, as well as assistance with financial aid and housing

- questions. DH asks about free parking for multi-cultural graduation ceremonies. C Ryan will approve requests sent to her on this. NS asks about President's award to faculty and what is the status of them. C Fowler says they will be announced very soon.
- 6.2 [Time Certain 2:50 pm] Report from ASI President Isaac Julian – ASI has adjusted their expectations for faculty, staff, students, and the campus institution. Over 1 million dollars have been invested in student activities. The Future U Project kicked off the campaign in November 2022. In December 2022, the Future U Survey was launched and received over 7,000 responses. The Smorgasport celebrated its 20th Anniversary with over 4,000 students joining games, rides, and activities. The opening of the Beach Kitchen is approaching, which works in partnership with the Beach pantry and campus departments. This provides students with valuable life skills and nutrition education. This includes partnerships with Cal fresh, hosting classes that allow students to obtain more knowledge on how to eat nutritiously, while also preparing low-cost affordable meals. The official opening of the ASI Go Beach Garden, a community garden dedicated to promoting gardening skills and providing fresh produce to our Beach community. All food grown in garden will be donated to Beach pantry. The last ASI election had 15% support, which is a record. I. Julian stated that the additional student fees for the Future U Project will not be over \$400.

7.1 [Time Certain 2:40 pm] Draft Resolution in Support of CSULB Faculty and Staff Parents and Caregivers — FIRST READING

Guests: Dr. Kirstyn Chun, Counselor Faculty, Counseling and Psychological Services; Dr. Lori Baralt, Chair of WGSS, CLA; Dr. Banafsheh Behzad, Associate Professor, Information Systems; Jason Deutschman, Associate Director of Academic Advising, Engineering Student Success Center, COE. - Change from presentation start time of 2:40pm to 2:25pm, VOTE (41 yes, 4 no). Motion passes. Moving this business item, K. Chun moved, seconded and approved. KC, BB, LB present slideshow which includes previous academic senate resolutions passes, why childcare is essential, initial response from the University that this was something they were not "entitled" to, and the specific components of the resolution. Questions and comments solicited. A guest, Jolene McCall speaks in support of this. AN asks about whether summer camps will be open in the future. AC states science camp is open. RF asks about cost; KC says no cost projection currently. Yousef Barker, CLA, supports this resolution. D Hamm speaks in favor of this resolution. KSG speaks as commentary, she states that it has never been the intention to state that childcare is a "privilege" she does not support that. This is a temporary closure with the reestablishment in 13 to 16 months. Since the university has not ceased childcare, just temporarily closing. YB states that the way they were communicated with did not follow the values of the University that they espouse. They were told of the renovation of the CFC, with collaboration available. Parents who had some complaints about the CFC then on January 3, he received a notice from the CFC regarding the closure. More information forthcoming it said, no further information was sent. Isabel Patterson was not told so they did not know about this. He feels the budget was used in a negative manner in this situation. He is worried that upon reopening the CFC may be available only to students, causing problems. KC says the goal of the resolution is to raise awareness. KSG states again that on behalf of the University much effort was put into this even though some

steps may have been missed. Understand it did not work out as an acceptable outcome for all, although efforts were made.

 - Line 382, to add ", at least every 10 years or earlier as determined" Moved by P. Ayala, seconded and approved. VOTE (12 yes, 30 no). Amendment fails.
 - Line 401, to add "The RTP committee members... latest policies and evaluation guidelines." Moved by S. Asgari, seconded and approved. VOTE (26 yes, 10 no).
 Amendment passes.
 - Line 432, to add ", at least every 10 years or earlier as determined" Moved by P. Ayala, seconded and approved. VOTE (13 yes, 26 no). Amendment fails.
 - Line 452, to add "facilitates mechanisms for guiding/mentoring candidates in the RTP process" P. Ayala moved, seconded and approved. VOTE (28 yes, 8 no). Amendment passes.
 - Line 491, to add "The periodic evaluation in the first year may... reviewed by the Department Chair and the Dean." Moved by C. Bennett, seconded and approved. VOTE (25 yes, 7 no). **Amendment passes.**
