Organizational Meeting for 2023-24 Academic Year

- 1. CALL TO ORDER 2:01pm PFH begins with land acknowledgment.
- 2. APPROVAL OF AGENDA Moved by N. Schurer, seconded and approved.
- 3. WELCOME OF NEW SENATORS New senators welcomed and introduced themselves. Poll everywhere function explained to new senators for attendance and voting.
- 4. ELECTION OF CHAIR One Candidate: Pei-Fang Hung. Vote: 48 in favor. **Pei-Fang Hung elected** as Senate Chair.
 - Each candidate will be allowed 60 seconds to make a statement.
- 5. ELECTION OF VICE CHAIR One Candidate: Neil Hultgren. Vote: 48 in favor. **Neil Hultgren elected as Senate Vice Chair.**
 - Each candidate will be allowed 60 seconds to make a statement.
- 6. ELECTION OF SECRETARY One Candidate: Ryan Fischer. Vote: 49 in favor. **Ryan Fischer** elected as Senate Secretary.
 - Each candidate will be allowed 60 seconds to make a statement.
- 7. SEQUENTIAL ELECTION OF **FOUR** MEMBERS AT LARGE OF THE EXECUTIVE COMMITTEE
 - Each candidate will be allowed 60 seconds to make a statement.
 - The four at-large members of the Executive Committee are elected sequentially, i.e., *first* we elect at-large member #1, *then* at-large member #2, *then* at-large member #3, and *finally* at-large member #4.
 - In each of those four elections, we take nominations from the floor and then vote on those nominees.
 - Then, two things can happen:
 - 1) Either one nominee receives at least 50% + 1 of the votes cast (abstentions do not count either way). In that case, that nominee is elected and we proceed to the next election.
 - 2) Or no nominee receives at least 50% + 1 of the votes cast. In that case, the nominee with the lowest number of votes is dropped from the ballot and we vote again on the remaining nominees.
 - Then (again), either one nominee is elected with at least 50% + 1 of the votes cast, or the nominee with the lowest number of votes is dropped from the ballot and we vote again—until one nominee has a majority of votes cast.

• For the next election of a member at large, any nominee from the previous election can be nominated again. However, that nomination is not automatic, but must be named. Then, we go through the whole process again.

 - 4.1 Executive Committee: Announcements PFH announces Babette Benken as the winner of the Nicholas Perkins Hardeman Award this year. A PP is shown to AS. She is presented with a framed certificate. PFH thanks the 2022-23 Executive Committee and presents their names to the Senate. Special thanks to Dr. Al Colburn and FPPC for his hard work on the RTP policy. - 6. SPECIAL ORDERS
 - 6.1 [Time Certain 2:40 pm] Report from CSULB President Jane Conoley
 - One CSU was hacked recently, shutting down all of their systems (doors, water, online courses, HVAC, etc.). It was one server that was vulnerable. Our IT folks are aware of it and are working to check older and vulnerable servers.
 - Commencement update 12,000 registered to graduate with 88,000 guests. Rented stages will be available and on campus for photo opportunities.
 - COZEN Report one thing relevant to our campus is bullying behavior. Encourages
 us to monitor our colleagues and say something when an issue arises. JC doesn't
 support an anonymous reporting system due to the dangers and potential misuse of
 such a system.
 - Senate resolution on workload JC says actions and decisions can be made now, at the college level, if the finances and resources are available. The University is reviewing potential cost estimates for the suggestions included in the resolution.
 - Will be announcing the recipients of the President's Awards soon.
 - JC has been at events for PBK, Vets, BUILD, etc. and says it is a joy to be around the students and hearing what they're accomplishing.

- QUESTIONS: MA asks about starting salaries that are 10% or more higher at other campuses (e.g. San Marcos). We are on par with Bakersfield. JC says she is aware, but one reason is because we have more faculty, and thus more people that we need to distribute the funding to.
- JC will not identify the campus that was attacked. Shares information that when it
 was originally reported in the local news near the campus, several more attacks
 occurred.
- DH asks about administrative bullying. JC says "give me their names, and I'll go talk to them." DH says she will.
- 6.2 Report from CFA Co-President, Deborah Hamm
 - DH presents on CFA work that is ongoing. Working for a 12% raise instead of a 4% raise. CFA supports bargaining which is beginning now. Many faculty with many voices in the union. There are five unions on campus and are meeting and strategizing for actions upcoming.
 - DH announces that she is retiring, and this is her last Senate meeting. She
 encourages everyone to work together to achieve their goals. Dr. Hamm receives a
 standing ovation for all her hard work over the years. She says we all need to work
 together to make our work life better.
