- 6. SPECIAL ORDERS
 - 6.1 Report from CSULB President Jane Conoley, TIME CERTAIN 2:10 PM
 - JC reports on the BOT meeting, the Board approved the proposal for new housing for students that would cost 30% less. \$53M received from State. We had 2,100 students on a waitlist to live on campus.
 - Tuition increase. Campuses don't have influence on that. The academic planning process that the CO handles. There are 20 year-old rules that state we should have been doing "that" (increases) all along. Other issues related to small programs with few majors changes include programs that have fewer than 10 undergrad and 5 grad students must be reported.
 - Program for Black Student Success.
 - We have hired a new tribal liaison (Thalia Gomez). Should help with our NAGPRA work.
 - Title IX and Other Conduct of Concern also discussed.
 - QUESTIONS:
 - NS academic planning how is it being balanced with having a "comprehensive University." Is it all financial, or will campuses have autonomy. JC says this isn't an issue for CSULB today, but we want to get ahead of it and figure out what we can do to help small programs. Our campus wants to maintain comprehensive programming.
 - KSG responds to JC's comments about academic planning. There is a formal name for it, "academic program portfolio maintenance." Focus is on recency, marketability, and attractiveness to our students.
 - Deborah Thien responds that as Dean of CLA they are very attentive and focused on creating and maintaining "comprehensive programming."
 - 6.2 Report from CFA Co-President, Shelly Collins
 - SC reports on CFA social today at 4 pm, at the Anatol Center until 6:30 pm. CFA Executive board presented. Currently reopening Bargaining. CSU opened the Benefits section, no decision yet. No resolution on the other topics yet, at an impasse. Will go to mediation next. Tuition hike of 6% passed by the BOT. Asks members to sign the "commit to take action." Syllabi statement provided.
 - QUESTIONS:
 - BK asks if CFA is discussing potential of "teaching only" tenure stream, as other institutions are doing. SC comments about "reimagining faculty" – longer contracts and entitlement may tie into that. Several members note how the UC has "lecturer with security of employment."

 - Line 57, S. Asgari amendment, moved and seconded. Add "the standards...policies." Vote on amendment: yes-52, no-3. Amendment passes.
 - Line 72, SA amendment, moved and seconded. Remove "include mechanisms." Discussion ensues. Amendment language modified. Vote on amendment: yes-47, no-5. Amendment passes.
 - Line 78 SA amendment, moved and seconded. Add/replace text "and guide candidates." Vote on amendment: yes-47, no-5. Amendment passes.
 - Line 87, SA amendment, moved and seconded. Replace with "shared governance." Vote on amendment: yes-39, no-10. Amendment passes.
 - Line 90, CB amendment, moved and seconded. Delete/replace with "Typically, faculty." Vote on amendment: yes-14, no-37. Amendment fails.
 - Line 114, BK amendment, moved and seconded. Delete word "other", moved and seconded. Approved by acclamation.
 - Line 150, BK amendment, moved and seconded. Add two sentences "Understanding student....and practices." Motion to separate the two sentences and vote separately. First sentence vote: yes-23, no-30. Motion fails. BK removes proposed amendment for second sentence.
 - Line 170, CB amendment, moved and seconded. Remove "and peers." Vote on amendment: yes-28, no-17. Amendment passes.
 - Line 171, SA amendment, moved and seconded. Add "if the assessment...to do so." Vote on amendment: yes-31, no-18. Amendment passes.
 - Line 213, SA amendment, moved and seconded. Delete word "language." SA withdraws amendment.
