 - AIEA (association for international education administrators) did a lot of lobbying to increase funding for federal funding programs.
 - Dept of Ed is intending to change rules cannot use any 3rd party agencies that are not US based. This will get decided soon and kick in in Sept if it passes
 - 3. USCIS students can now apply up to a year in advance for visas but students can only enter 60 days prior to start of school.

By having clear working groups and clearly defining the roles and responsibilities of the committee, we can 1. do a better job and 2. be able to clearly articulate what the committee does.

Commented [AK3R2]: There is already a document that has the procedures for subcommittees.

Commented [AR4R2]: Where is the document that has procedures for subcommittees? As I understand it, any subcommittee under the IEC have been running unofficially and are not recognized by Academic Senate. Many of the duties of these "subcommittees" should be brought into the IEC and made into Ad Hoc working groups, when necessary and made up of IEC members. It will make processes and procedures much more transparent.

The working group needs to consist of faculty who have previously taught on one of the programs and perhaps one IEC member to convene the group.

The working group members are made up of current IEC members. Volunteer members for each working group will be requested at IEC meetings. The size of each working group will depend on need and workload.

Additional individuals from the campus will work with the following working groups. Fulbright application feedback working group is led by the campus Fulbright Scholarship Advisor <u>(FSA)</u>. Additional campus members may join at the request of the FSA.

Semester-long, <u>faculty-led</u> study abroad programs working group <u>will include</u> faculty members who previously <u>taught on one of the faculty-led semester programs</u> The invitation will be made by the IEC vice chair. When the work begins the working group will elect a chair.

ASI scholarship review working group works with ASI and the Study Abroad office and will therefore work with other campus members invited by those entities.
