Can I require my students to turn on their cameras during an online synchronous session?	Yes, faculty can require students to turn on their cameras during a synchronous online course to demonstrate mastery of learning or demonstrate understanding of a concept. Students will be notified in registration that camera use may be required for synchronous online courses. Faculty will not require students to show their settings (i.e., removing a Zoom filter, asking to scan surroundings, etc.) Students who express a need for disability accommodation should be referred to BMAC and faculty should not require them to turn on their cameras until further consultations with BMAC. If testing requires on-camera use, ATS recommends <u>Respondus LockDown</u> <u>Browser and Monitor</u> for proctored exams. However, please note that these resources are not compatible to run on assistive technology software available to <u>BMAC</u> students, and should be disabled for those students. No, there may be factors that may lead to equity and accessibility issues for your students.	•	If you are concerned with students using headphones to cheat in your course, reach out to Student Conduct and Ethical Development Office to determine possible alternatives and to learn more about student rights. I am thinking about using a proctoring tool in my class, what do I need to take into consideration?	If remote proctoring services will be used, strong efforts need to be made to ensure that resource issues (e.g. technology, hardware/software, accessibility, finances) do not impact students' ability to perform. ATS recommends, <u>Respondus LockDown</u> <u>Browser and Monitor</u> for proctored exams. However, these are not compatible to run on assistive technology software available to <u>BMAC</u> students, and should be disabled for those students.	•	Do not require students to show their settings (i.e., removing a Zoom filter, asking to scan surroundings, etc.) Faculty are encouraged to develop alternative assessments for online courses that do not require camera use. Become familiar with the CARES Act and encourage students to contact the Division of Student Affairs and visit the CARES ACT website to learn more about ways in how CSULB is working in bridging the digital divide (e.g., laptop program, outdoor wi-fi, student virtual labs and Open Access computer labs). Inform your students about <u>open labs</u> <u>on campus</u> . I have decided to use a proctoring tool for my <u>online</u> class, however, do students have the right not to share their screens or turn on their cameras while using the proctoring tool during an assessment?	No, online students do not have the right to turn off their cameras or not share their screens, when asked. Therefore, faculty can require students to turn on their cameras during a proctored assessment. Faculty will not require students to show their settings (i.e., removing a Zoom filter, asking to scan surroundings, etc.) If testing requires on-camera use, ATS recommends <u>Respondus LockDown</u> <u>Browser and Monitor</u> for proctored exams. However, please note that these resources are not compatible to run on assistive technology software available to <u>BMAC</u> students, and should be disabled for those students.	•	Reach out to <u>BMAC-Exams@csulb.edu</u> about Respondus features related to <u>BMAC</u> students. Do students need to be informed if the class session is going to be recorded?	Yes, faculty must inform students every time class session will be recorded.	 Include a statement in your syllabus informing your students that class sessions will be recorded. Before class, inform your students through email that the class session will be recorded. If a student does not want to be recorded during a class session, what do I do?	Faculty can require students to turn on their cameras during a synchronous online course. Students will be notified in registration that camera use may be required for synchronous online courses.	 Faculty must clearly state in the syllabus the on-camera requirements for a course. Can I share the class session recording outside of class with others not enrolled in the class?	No, faculty should provide the same level of privacy in the virtual instruction they provide in person and consider the recording to be a private record for the registered members of the class only. Contact the Bob Murphy Access Center for information on providing your student/s with accommodations. Yes, possibly, especially if the student is using assistive technology (e.g., screen reader). Students who express a need for disability accommodation should be referred to BMAC and faculty should not require them to turn on their cameras until further consultations with BMAC. If testing requires on-camera use, ATS recommends <u>Respondus LockDown</u> <u>Browser and Monitor</u> for proctored exams. However, please note that these resources are not compatible to run on assistive technology software available to <u>BMAC</u> students, and should be disabled for those students.	•	best way in how to work with you throughout the semester.
