- 1. Approval of the agenda: Approved as amended.
 - a. Proposed amendment: Consent calendar item: GE Supplement from GEGC for Fall 2024
- 2. Approval of minutes from November 8th, 2023 Meeting: Approved.
- 3. Announcements:

- 4. Proposed new credential, **PK-3 Early Childhood Education Specialist Instruction Credential Program** (First Reading) (Time Certain: 2:15pm)
 - a. Ruth Piker.
 - b. Governor wants CA to offer universal pre-school, starting academic year 25-26. TK will eventually be the new universal pre-k. Need to hire 12,000 new teachers.
 - c. Every CSU has been asked to put together this credential program, specific for pre-k through 3rd grade.
 - d. Q: How different is this from what you are currently doing? A: K-8th grade cred is currently offered. To teach transitional kindergarten you currently need 24 units of early childhood development. We will share many resources with multiple subject credential.
 - e. Q: How many new courses? A: 13 courses.
 - f. Q: One of the goals is to cater to bilingual students. In the description of literacy courses, there is nothing on bilingualism A: We will add more things as time goes on.



- g. Q: For the regular elementary credential, there are 12+ units of math. We feel there should be consultation with the Math Department. A: Science and math classes will be developed in the spring in consultation with math and science faculty. Until we start offering the course and know where our candidates are, we can't develop the math and sci courses yet. The candidates will already have a bachelor's degree, and will have math from their undergraduate degree.
- h. Clarification that student teaching is a full-time activity.
- i. Q: Can they take pre-reqs during undergrad? Yes. But co-reqs cannot be taken as an undergrad.
- j. Comment: Would be helpful to have courses that candidates who want to improve their skills teaching math would be able to choose.
- k. Comment: Need library report.
- 5. Proposed new **Policy on Academic Internships** in response to Chancellor's Office Executive Order 1064) (Second Reading) (Time Certain: 2:45pm)
 - a. Incorporated comments from previous reading.
 - b. Request for clarification of name of policy, as well as affiliation agreements/student field placement agreements.

 - d. Q: Is there guidance on how to do the reviews?

- d. Q: I'm assuming this is a normal number of units? A: Yes. Engineering is a high-unit major.

- f. Q: How are you making sure first year students are making progress? A: Within first 60 units, they must finish their Major Specific Degree Requirements, which transfers will already have done.
