11:26 -11:52: Discussion Topic: Repeat and Average Grading Policy, Sarah Schrank

Moved to this topic at 10:40 since Sam/Paulina/Cynthia had not yet joined the meeting.

- Nuts & Bolts of Grade Forgiveness
  - Only 1-course one time?
  - o Maximum number of repeats for forgiveness?
  - o Any course or required earned C or below?
  - o Earned same or lower grade?
  - Forgive only to get into good standing (academic warning or not)?
  - O Must graduate advisor request forgiveness?
- Babette Benken Some campuses that do allow to repeat, the highest grade is the one accepted.

- Often a class is only offered once a year, so the course could not necessarily be taken in the immediate next semester.
- Highly in favor of determining a process, its very specific situations of students who may disappear but almost impossible for them to come up to good standing because its more than one class during that semester.
- Jody Cormack She explained that this is not common across the CSUs. As result, she queries the group to consider the ramifications.
- Sarah Schrank CLA advisors had strong feelings for and opposed grade forgiveness. Those opposed were concerned about the potential for frequent and unlimited repeat/deletes.
- Caitlin Murdock wondered if the group would want to grant only D/F grades vs C grades.
- Mary Ann Rose CED took a poll and were in favor. As the person who manages the process, preference would be on a case-by-case scenario, as it could make it possible to remediate the student's GPA.
- Virginia Gray In CHHS, faculty are in favor of 1 course to be repeated and deleted and would prefer
  ubiquitously rather than case-by-case.
- Vesna Terzic COE is in favor of one course, and more than one could be on a case-by-case basis. They are most concerned with international students. In their first semester, many struggle due to their transition to the US. COE only considered Ds and Fs.
- Jody Cormack she is in favor of 1 course, unless the master's degree is higher than 60 units. The percentage of the degree can be compromised if its more than one course. For example, 30 units for a degree so 1 course is 10% of program. 60 unit or higher master's degree can possibly have 2 courses.
- Meghan Griffith- Pina This will likely be a manual process to start, but we may be able to automate it since there is a process in place for undergrads at the CSU Wide level.
- Virginia Gray -She suggested it could be an 'advisor request'.
- Wrap Up of Conversation
  - Jody Cormack: There seems to be consensus amongst colleges, suggest next steps is to:
    - Author a draft of the language and place it into amendment form so that we can look at it as a whole group during the GSAC February 2024.
    - Create a sub-group of individuals to craft language in the spring before sending it to the Academic Senate Floor.
