# **Policies**

# **Student Behavior**

The University policy states: "If a student displays disruptive behavior that substantially interferes with the educational environment, the Professor can ask the student to leave class for that period". Students may use laptops or tablets in class to take notes or view lecture material. Phones should be silenced during class and turned off during exams. Students using their laptops, tablets, or any other communication devices for any reason during exams and quizzes will receive a zero score on that test."

# Plagiarism/Academic Integrity Policy

In its policy on <u>Academic Integrity (PS 21-01</u>), the University defines plagiarism as:

The act of using the ideas or work of another person or persons as if they were one's own, without giving credit to the source. Such an act is not plagiarism if it is ascertained that the ideas were arrived at through independent reasoning or logic or where the thought or idea is common knowledge. Acknowledgement of an original author or source must be made through appropriate references, i.e., quotation marks, footnotes, or commentary. Both quoted and paraphrased materials must be given proper citations.

Self-plagiarism is generally defined as re-use of one's own work for multiple assignments within one or multiple courses, or presenting previous work in another context without citing it as one's own.

Work that you submit is assumed to be original for this assignment unless your source material is documented appropriately, such as a Works Cited page. Using the ideas or words of another person, even a peer, or a web site, as if it were your own, is plagiarism.

#### Generative AI (Artifical Intelligence)

The use of generative Artificial Intelligence (AI) tools in this course must, first and foremost, follow the guidelines set by the instructor. If such use is permitted by the instructor, your use of AI tools must be properly documented and cited in order to follow CSULB's <u>Policy on Academic Integrity Regarding</u> <u>Cheating and Plagiarism</u>. See these resources for <u>APA guidance</u>, and for <u>other citation formats</u>. Any assignment that is found to have used generative AI tools in unauthorized ways may incur a penalty, as determined by your instructor. When in doubt about permitted usage, please ask the instructor for clarification. An individual or group caught using AI to cheat on any exam/quiz or plagiarism will receive no credit for the work concerned. Their letter grade may also be lowered depending on the extent of academic dishonesty. You may also consult the section on a<u>cademic integrity in the CSULB catalog</u>.

# Drops and Withdrawals at CSULB via MyCSULB

Per the CNSM Guide to Drops and Withdrawals – Spring 2024, "<u>Using Academics</u>" guides students through self-service schedule adjustments options available in MyCSULB during the first three\* weeks of class. Classes dropped during this time will not appear on students' permanent records.

Note: Neither Instructors nor Departments are required to drop a student who is registered in a class. Students who do not attend class or stop attending class are responsible to initiate a Drop or Withdrawal.

After the first three\* weeks of class, students may initiate withdrawals from class through MyCSULB. Instructions are located under the Request to Withdraw tab at <u>Using Academics</u>.

**Important:** If withdrawing after the third week of instruction, a "W" will appear on the student's permanent record. Students should consider the consequences of this action and consult their academic advisor. After the third week of the term, withdrawals can impact progress towards degree, future course enrollment, current financial aid awards, and future financial aid eligibility. In most instances, the withdrawal units will be applied to the student's Undergraduate Withdrawal Limit (18 units over the course of their entire CSULB undergraduate career).

Students should also be aware that after the 3rd week of instruction, class withdrawals are permissible only for serious and compelling reasons. The definition of serious and compelling reasons as applied by

faculty and administrators will be defined more narrowly as the term progresses. Please be advised that poor academic performance or poor time management is not justification for withdrawing from classes.

\*For the Spring 2024 Semester, the drop-without-penalty date has been extended one week to Sunday, 2/11/24 @ 11:59pm. PS 22-01 states that during the "first two weeks" students may self-adjust their classes without penalty. Also, during this time, instructors may drop students who have not attended. Due to the extenuating circumstances of the labor stoppage, self-adjustment has been extended to the third week of the semester.

#### Spring 2024 Timeline for Drops and Withdrawals

**1/22/2024 - 2/11/2024:** Students may drop classes through MyCSULB via <u>Single Sign-On</u>. These drops will not appear on students' permanent records.

**2/12/2024 – 4/19/2024: Withdrawal after first 3 weeks and prior to the final 3 weeks of instruction:** Students access MyCSULB via <u>Single Sign-On</u> and click on the "Enroll" link in the Academics section. Next, click the "Withdraw" tab. To initiate a withdrawal request, click on "Create New Request" button. If appropriate, attach documentation.

**4/20/2024 – 5/10/2024: Catastrophic Withdrawal during the Final 3 Weeks of Instruction:** Note that withdrawal during the final three weeks of instruction is not permitted unless there are serious and extenuating circumstances beyond your control that prevent you from continuing in your classes and incompletes are not possible.

Follow the directions at the "Withdraw" tab in the Academics Section of MyCSULB, accessed via <u>Single</u> <u>Sign-On</u>. Justification and supporting documentation are required and must be uploaded with the request to withdraw. Approvals required include the student's instructor, the chairperson of the department offering the class, and the Associate Dean of the college in which the class is offered. All requests will be submitted to the Withdrawal Committee for review. Students will receive an email with the decision.

# **Attendance Policy**

Students are expected to attend classes regularly. Class attendance and participation are necessary and important components of learning that affect all students in the class and are essential to achieving a course's educational objectives. #### **Eliminating Anti-Blackness**
