10:48-10:55: **Academic Senate Updates** – Neil Hultgren (Chair, Academic Senate)

- Senate has had 2 meetings so far; polies that have been in discussion
 - o Policy on GWAR
 - Policy on deadline for adding classes (1985); the council has already advised, but a few edits needed for language purposes
 - o Rights and privileges on a Emeritus for faculty and have a gender-inclusive naming convention to Emeritx
- The Provost office seeking to have a unified grade appeal form; if colleges are interested to know their colleges rep. Neil can provide the link to the roster for the representative of each college
- Currently working on staffing the search committee for the Dean of Graduate Studies positions; looking for tenured faculty (4) to participate and one lecture (1) minimum half-time base
- Questions?
 - o Sarah: About the Meritus language change; is the change going to be uniformed?
 - It does not talk about if you get to choose which one, but allows the ability to talk about the category without talking about it in a gender-restrictive form
 - O Dina: What about staff, if they would like to be on it?
 - Staff Council met last Friday and may have already selected a person for the committee; there is a staff member to be on the committee.

- Regularly check Canvas updates and review the monthly newsletter
 - Remind your graduate advisors that the Canvas exist for resources and updates
 - o The syllabus is updated for graduate advisors to have access to it.
 - Will update the GSAC roster to be able to receive the newsletter as well.
 - Sarah shared that students get their own student monthly newsletter for updates, so to be sure not to share the graduate advisor newsletter to students as there is specific information for only geared for advisors.
 - At the end of the newsletter is a checklist of things that need to be completed.
- Confirm deadlines on the <u>Grad Advisors webpage</u> are accurate and up-to-date
 - We utilize the site to update the students about the deadlines for their programs for application and accepting/declining admission decisions

11:07-11:18: Presentation: GS Annual Report & Executive Summaries – Dina Perrone (Interim Dean of Grad Studies)

- Sharing a snapshot of each college as well that gets shared with the Provost of what is happening with statistics of their students.
- Graduate Education Lifecycle: admission > grad advising > student success & belonging > graduation > creative, service, scholarly activity
- Scope of supports that GS provides:
 - Recruiting; guiding graduate advisors, honoring graduate student success, offer variety of workshops for professional development; writing supports to name a few
- Recruitment & access activity
 - o EAB
 - 5 Regional grad fairs
 - o 100% of those who met with the GC Coordinators and applied to CSULB got admitted (YAY!)
- Spring 2025, the GC receeived 232 admissions-related inquiries: prerequisites,
- Guiding grad advisors
 - o Data summit
- Honoring Grad student success
 - \$54,000 graduate travel fellowship (115 recipients)
 - o Deans List
- Enhancing Graduate Student
 - o 871 attended the CSULB-Wide graduate student orientation
 - 4 networking events
 - o 200 participates in GradMentor program

- Professional Developemnt
 - o Grad Slam
 - Student Research Competition
- Graduation Initiative's

- This is currently geared for thesis and dissertation; but if there are more requests for advance classes it will be revised for the workflow.
- Executive Summaries
 - Located in GSAC folder college-specific summaries
 - Content derived from the annual report to tailor to college-specific data points; it was shared with the Deans of each college
 - o If you have any specific data points that you are wondering about and want to be highlighted in the summary to let Dina know.
 - Like common exceptions
 - Number of thesis

11:36-11:41: Establishing Beach EDGE Policy—Timeline: Goal of Finalized Draft by Mar 27th

- Subcommittee Formation
- Beach EDGE is a blended bachelor's & master's program
- Currently 20 established programs; with several in the pipeline
- There is a CSU-wide blended programs policy; however, there has been different things that have been on notice in the adoption on the CSULB campus. Such considerations include:
 - Double majors how it impacts to be in a blended
 - State-side and self-supported blended programs
 - Blend from different campuses
- Questions?
 - Sara: Does the policy need to go to Senate Executive Committee or CPEC?
 - Neil: It will be sent to Executive Committee and they will funnel it to the committee that is appropriate to review
 - Alysa: Will there be a flowchart available?
 - GS to work on creating the flowchart
 - Rebecca: Are there conversations about teaching credential programs? There is a ITEP program (it has been able to withstand at CSULB but not at other campuses (which is a 4+1 program)?
 - Moving towards combined masters with teaching credential, how to integrate these teaching credential programs (4+2).
 - Dina 12 units are counting from the credential to master's degree, this is not changing
 - Blended certificates: 15 units counting towards master's degree.
 - Deans have not talked about this much however.
 - Alysa—Currently working on the first blended state side and self-support program
 - Students can mix classes with state side support
 - Piloting the first one
