  - a) Suggestion to create spaces for discussion and teaching about the issues
  - b) This connects to the TPM policy and concerns about free speech and spaces for discussion
  - c) Suggestion to invite Catherine Ward from Truth, Racial Healing & Transformation (THRC)

- 1) Could there be an option for an emergency or rapid response to create an event, a protest or a teach-in?
- 2) Can administrators responsible for creating the policy provide information to both students and faculty about why the TPM policy is in place and clarify the intent behind the policy
