5. SPECIAL ORDERS

- 5.1 Report from President Conoley TIME CERTAIN 2:10 PM- JC reports one of our CSULB students was stopped at HNL and deported (visa removed); no advanced notice given; Other international students from other universities have been deported, happening in a very different way than in the past. We are part of a legal case challenging these rulings. Many faculty members have had Grants canceled, trying to find a way to buffer these in the current budget situation. JC encourages members to contact their Senators and Congress persons. Secret service came on campus alleging a student made a direct threat against the POTUS, they requested student schedule information, none given.
- 5.2 Report from CFA Long Beach Faculty Rights Chair Kelly Janousek- KJ reports on CFA happenings. 4-17-25 National day of action for higher education, KJ encourages all to participate. Will start at 11:30a.m. at upper quad and march to Brotman Hall. Looking to have good representation. CFA membership also includes access/membership to AAUP. National issue, not just campus. Staff and students can join on 4/17.

6. NEW BUSINESS

6.1 [Time Certain 3:30 pm] Proposed revision of PS 12-12: Graduation Writing Assessment Requirement (GWAR) in two parts: a policy and a committee charge (AS-1207-23/CEPC) -- FIRST READING Guest: Jeff Bentley, Chair, Curriculum and Educational Policies Council- JB presents on the GWAR policy revision. Moves to Second reading at next AS meeting.

CM: should we rename (GWAR to UWR- Univ. Writing Requirement)? JB: unsure, UWR is a broader term that might be more appropriate. RF: In the charge for the UWRC, would set qualifications for faculty... how drastically would this impact the current status quo- e.g. CCEJM faculty teaching and if there would be a major impact on who would be allowed to teach. JB: was not committee's intention to make it more restrictive in the sense of who would be allowed to teach. Adam: are we allowed to require non-credit bearing requirements as pre-reqs for students (reqs for struggling students)? PFH: for CO, we cannot add units. But we could offer learning modules or student support, CO does not prohibit. Spirit of CO policy is that we cannot add units for GWAR. NS: Disputes statement about GPE being "high stakes" and CO concern about GPE fee for students. In terms of reqs, will every student in university get same writing reqs? JB: yes, but if they get less than a C, they will be offered modules. Concerns about equity vs. equality. CW: depts creating WI courses- JB: committee removed language requiring depts to create their own WI course. A dept can still do that, but wanted to remove burden

on depts to be required to do so. KJ: UD area 3 (past area C), this does require 2500 words. All students must take this course and will be required to write 2500 words.
