The School of Social Work and the School will not process any application that is missing documents or information. The supplemental 2026 BASW application packet must include the following:

- a complete 2026 BASW Admission Application (signed and dated);
- an autobiographical statement (instructions included in the application);
- Two (2) 2026 Reference Forms (forms and instructions included in the application).

All materials submitted to the School of Social Work become official University property. Official Transcripts must be submitted to University Enrollment Services once the applicant has been instructed to do so. Incomplete and late applications will not be evaluated.

The School of Social Work determines the practicum agencies to which students will be assigned, and the majority of practicum agencies are located in low income, urban areas. If admitted to the BASW program, the student agrees to accept the practicum experience assigned by the practicum faculty of the School. Once admitted, students are not allowed to switch from daytime to evening courses or vice versa, except with the permission of the Undergraduate Program Director.

Admitted students must complete the co-requisite requirements (i.e. completion of Graduation Writing Assessment Requirement Placement Exam - GPE and Abnormal Psychology course) by the end of the junior year. In addition, all Social Work courses must be completed with a grade of "C" or better, and all practicum and field experience course must be completed with a "CR" (credit grade), as well.

Give a brief discussions of a problem you have encountered in an employment or volunteer situation and how you resolved it. If you have neither employment nor volunteer experience, you may discuss a personal challenge that you faced.
