

### Financial Affidavit Instructions for F1 International Students

To receive an I-20 and F-1 visa, the U.S. government requires applicants to provide evidence of sufficient funds for their first academic year of study in the United States at California State University, Long Beach (CSULB). The total cost shown is the minimum amount required only for the I-20. Actual program costs may be higher. Please see the attached **Cost of Attendance Components on the I-20 Financial Affidavit** sheet for information about calculating your own actual cost of attendance.

#### Documentation Requirements

1. All documents must be dated within the past 6 months.
2. All documents must be in English, or you may attach a certified English translation of original documents.
3. Family, Private Sponsor, or Personal Funds: Official bank/financial statement must show your sponsor's name and the amount provided (NOT a transaction history). Limited to 5 statements.
4. Government Sponsorship or CSULB Scholarship: Official letter must show California State University, Long Beach (CSULB) as the student's school, validity period of financial support, and the amount provided.
5. Dependent Information: Additional amount of \$4700 for spouse, and \$3900 for each child.
6. Copy of current passport and/or dependent(s) passport copy.

These are the **Estimated Expenses for Academic Year 2025-2026** for a typical nonresident student for the first year of study and minimum required units. Actual costs of living vary by individual choices related to location and circumstances, so please plan accordingly. Certain graduate professional programs, such as MBA or credential, have higher tuition. See your program website for additional cost information.

### Cost of Attendance Components on the I-20 Financial Affidavit

Cost of Attendance is the average cost to attend CSULB for your first academic year only, which consists of the fall and spring semesters. You will need to make sure that you have enough funding for your entire program until you graduate.

The amount required for the I-20 reflects the estimated expenses for **Academic Year 2025-2026** for a typical nonresident student in the first year of study. These estimates are based on the annually published [Cost of Attendance numbers by the CSULB Financial Aid office](#). Please regard all CSU listed fees as **minimum cost estimates** that are subject to change.

**For the I-20 Financial Affidavit**, you must provide proof of funding for the amount listed next to **TOTAL** for your degree level. Your actual cost may be less or more than this amount depending on your choices.

#### Components Included in the Cost of Attendance for I-20:

**1) Tuition and Fees** are a sum of money charged for teaching or instruction by the university. All students enrolled at a CSU campus pay the base systemwide tuition fee, plus the campus mandatory fees. Please check the [CSULB Tuition and Fees](#) page for a breakdown of the costs.

- **Non-Resident Tuition (NRT)** is an additional tuition fee for all non-California residents, which include **F-1 students**. This NRT fee is calculated into the Tuition and Fees section on the I-20 affidavit for the first year of studies. Your actual tuition cost will depend on the number of units you take, which is an additional **\$444.00 USD for each unit**, plus the total CSU tuition and fees.

**2) Living Expenses** are the average \*housing and food cost per academic year to live in Long Beach with a roommate while attending CSULB. **Actual costs will vary** by individual choices related to location and circumstances (on-campus, off-campus). The required amount on the I-20 affidavit also includes the estimated amount for books and transportation for the first year of studies.

- Book expenses are the average cost of books, course materials, supplies, and equipment, and cost of a computer per academic year.
- Transportation expenses are the average cost of traveling to and from CSULB. This amount **does not include car payments, insurance, parking fees, or vehicle maintenance**.

**3) Health Insurance** is mandatory for all F-1 international students before registering for courses. This insurance requirement is a CSU systemwide mandate that cannot be waived and must be purchased through the school's insurance provider. The cost of insurance will vary each year.

The cost of attendance does NOT include inflation or miscellaneous personal expenses, which vary by person and choice. The total amount required on the I-20 affidavit is based on your **first academic year of study**, which is 2 semesters, and a minimum of 12 units per semester (24 units per year) for undergraduate students and 9 units per semester (18 units per year) for graduate students. Certain graduate programs, such as MBA or credential, have higher tuition and greater credit requirements. Refer to your program website for updated tuition information.

**Not Included in Cost of Attendance for I-20**

- **Miscellaneous Personal Expenses** are the average amount for personal expenses—from clothing and laundry to going to a movie or buying a pizza—each year. The required amount on the **I-20 does NOT include** miscellaneous personal expenses. CSULB's Financial Aid office currently estimates about an **additional \$423.00 USD per month** for miscellaneous expenses. Your actual individual student expenses will vary based on the choices you make for living costs and on the number of units you take in your program.

**\*For informational purposes only:** In accordance with California Assembly Bill 990, California State University, Long Beach provides the typical market cost of a one-bedroom apartment in the Long Beach area: 1 Bedroom: \$2,623 per month.
