# -Q & A:

-Cindy questioned breakdown between in person, online, hybrid. Answer: 73% in person and 26% Hybrid or Online.

- -David asked about being CSULB being envy of CSU system for applications and enrollment: Answer: highlighted we are top 8 in applications in nation and the issue with the waitlist and enrollment and how this influences the other CSUs. Requests from other CSUs to release our waitlists sooner.
- -Cindy asked when we release our waitlist. Answer: depends on how are yield is going and meeting out targets.
- -Josh asked a question about yields. Answer: We use data on trends and know 50% usually accept and we use waitlist if say only 40% accept and we use the waitlist to get to the 50%.
- -Ellen asked how many average apps to CSU per student. Answer: Online apps make it easier to apply to several CSUs.
- -Ali asked about graduate applications declining and why that might be. Answer: depends on job market more jobs less graduate applicants.
- -Josh asked about numbers who come in as a specific major and graduate with that major. Answer: We have those data if you would like to view them, as well as data on grad apps by college.
- -David asked about the increase of women in higher education, trends over time, and initiatives to increase male enrollment. Answer: Disparity started in the 1980's between men and women in higher education. Accelerating in certain spaces like education. Had a discussion CSU wide to develop an initiative, but there were no specifics given about an initiative.
- -Jesse asked about recruitment of men and the application pool. Answer: The disparity is built into the application pool.
