Salary Range

The part-time lecturer (AY) classification is \$5,507 to \$13,224 per month (and 12 monthly payments for a full-time (30 WTU) appointment. The typical salary of a 3-unit class ranges from \$6,600 to \$8,700 for the semester (but will be paid in 6 monthly payments of \$1,100 to \$1,450 each). Salary offered is commensurate with qualifications and experience.

University Mentors are assigned to specific student teachers during their semester assignment and are compensated at 0.5 WTU per student teacher.

Required Qualifications

- 1. Extensive experience as a mathematics classroom teacher or school administrator (grades 6-12) or experience as a teacher-educator (e.g., teaching courses in pedagogy, researching the learning of teachers) and experience working with in-/pre-service teachers at school sites.
- 2. An advanced degree (e.g., M.A., M.S., M.A.T., Ph.D.) in Mathematics, Statistics, Mathematics Education, Education (with a focus in mathematics) or related discipline.
- 3. Demonstrated potential for teaching excellence.
- 4. Demonstrated commitment to working successfully with a diverse student population, including Black/African American, Latine/x, Native American/Indigenous, low-income, first-generation, and minoritized students.

Duties

Serve as University Mentor teaching EDSS 472A, EDSS 472B, and EDSS 472C (Student Teaching). Mentor and provide feedback to student teachers in the Single Subject Credential Program, including conducting observations on-site in middle and high schools. Act as liaison between student teachers, cooperating teachers, school and district administrators, university administrators of the SSCP, and the Single Subject Credential Advisor and Student Teacher/Intern Coordinator in the Department of Mathematics and Statistics.

Employment Requirements

A background check (including a criminal record check and telephone reference check with most recent employer) must be completed satisfactorily before any candidate can be offered a position with the CSU. Failure to satisfactorily complete the background check may affect the application status of applicants or continued employment of current CSU employees who apply for the position.
