4. REPORTS OF STANDING COMMITTEES AND COUNCILS
  - 4.1 Executive Committee: Announcements- NH announces nominations open for an ASCSU member for a three-year term. NH reminds senators on the amendment process, and the question/comment protocol, as well as the speakers list. Deliberation process with three for and three against. No amendments to be made from the floor, only in advance.

6. SPECIAL ORDERS
  - 6.1 [Time Certain 2:10 pm] Report from President Andrew Jones- AJ introduced the incoming President, Dr. Loren Blanchard to the Senate. LB spoke to Senate on his plans for the next few months on campus. Student success is a priority for LB moving forward. Spoke about his history with the system, David Dowell, and commended our campus for its excellent programming, and examples of student success. Many students from Houston reached out to him about his recent appointment offering congratulations and stories from alumni. He expressed appreciated Andy Jones and all his hard work in the interim. NS asked what student success means to him and how to achieve it. Knowledge skills, and professional dispositions ready for the workforce or higher education. Academic and co-curricular side with leadership acumen. He plans to do listening sessions to understand more about our campus.. BK asked about EO 1110, and how he involved, what did he or the CSU learn from this EO, will this affect his work here. President said it was a system-wide initiative, and we need to look at those, but it's in the past. Wants to focus on city connection with the mayor to harness what we do to address deep seated issues. EK says when LB left the CO, herself and others were sad, and reported he was a good listener. SD commended their statement and asked about communication and encouraged more updates. AN asked about the bonus offered by the chancellor. That was the COs primary salary increase, which the union rejected.
  - 6.2 Report from CFA Long Beach Co-President Shelly Collins- SC presented on bargaining, a town hall happened on 2-3-26, proposals were presented to the members, including changes in layoffs, removing grievance procedures, removing letters in file, and sabbatical changes were presented. Items that were rejected in the

bargaining proposal were presented. A senate bill regarding immigration was addressed. An all member will be held February 10th, 430-5 in amatol. And February 11 on zoom. SD asked about the current situation in Iran, SC says there is a statement forthcoming, a vote is in process on this statement. Will likely be distributed next Monday. AN asked about the bonus that was declined to move forward with step increases. One time bonus to non-union faculty & staff was proposed. The union bargaining team does not agree with a one-time payment.

- 6.3 [Report](#) on ASCSU Plenary from ASCSU Senator Norbert Schürer- NS presented on the recent ASCSU plenary meeting in January. He encouraged senators to reach out to ASCSU senators to support any of the resolutions passed recently. He presented first reading items which are open for feedback. The Student Success Framework coming from the CSU COs office. He presented the difference between resolutions and policies and how they are dealt with at the CO. AN asked about the discipline specific councils. RS thanked the three ASCSU senators for their hard work.

- 7.1 [Time Certain 3:45 pm] [Renaming of the College of Engineering](#) – FIRST READING

Guests: Jinny Rhee, Dean, College of Engineering; Dan Montoya, Vice President, University Relations and Development- JR and DM presented on the renaming of COE. Moved, and seconded. The proposal is in the linked documents. The use and timing of the funding is explained by Dean Rhee. She thanked CEPC, Senate, the COE curriculum and COE faculty council for their work on expediting this process. NS asked about the delivery of money and if it was contingent on the name. It was part of the gift agreement. KSG makes a motion to waive the first reading, seconded. Vote on waiving the first reading, yes-39 no-2. motion passes. Vote on the renaming proposal. Yes-41 no-6. Proposal for the renaming of COE passes.

- 8.1 Proposed revision of PS 12-12: Graduation Writing Assessment Requirement (GWAR): remaining part: a committee charge (AS-1207-23/CEPC) -- SECOND READING- resuming on line 24, NS amendment, moved and seconded. Add language “access...at the University” PFH friendly amendment, NS accepts. Add language about PS 22-19, consistent with...vote on amendment, yes-44 no-2. amendment passes. Line 35, NS amendment, delete language. Approved by acclamation. Line 35, NS amendment, change language, grammatical change, approved by acclamation. Line 36, CM amendment, delete language. Moved and seconded. BK friendly amendment, keep the 1<sup>st</sup> sentence, delete the rest. Vote on amendment, yes-44 no-0. amendment passes. Line 41, BK amendment, moved and seconded. Add language “non-voting” approved by acclamation. Line 44, amendment to delete language, moved and seconded. Approved by acclamation. Line 43, NS amendment, change language, replace with “all faculty members” moved and seconded, friendly amendment, add “but preferably all” CB makes a motion to suspend the rules to allow us to delete the sentence. Vote to suspend the rules, need a 2/3 majority. Yes-26 no-18. Motion fails. Friendly amendment, “preferably all” NS says not friendly. Vote on amendment, yes-29 no-16. Line 55,

CM amendment, change language, moved and seconded. Vote on amendment, yes-39 no-5. amendment passes. Stopping at Line 56/end of 55.
