## 2012 Innovation Challenge Winners: CBA Students Matt Martin and Ryan Beck

The Innovation Challenge Final Presentations held on April 3rd went great. All four finalists gave excellent presentations and all of the ideas were well thought out and have the potential to be great companies.

The <u>Innovation Challenge</u> is a business plan competition that is a partnership between the CBA and College of Engineering; the IC is open to all students throughout the university.

The first team to present was the Mobile Mohs Machine, a machine that is used to prepare skin samples for medical evaluation. This team was a husband and wife team, Khristine Pugeda Paustell and Cody Paustell. Khristine has created a design for a mobile Mohs machine that costs about 50% less and weighed about half as much as current models that are available to Mohs technicians like her husband.

The next team to present, and the eventual winning team, was Glyde Tech. Presenters and CBA students Ryan Beck and Matt Martin gave a spirited presentation complete with props, music and a fully-functioning prototype. Glyde Tech had designed a technology, based off of magnets, to improve quality and performance of sliding glass doors and windows: convert your slider into a glider. Through their presentation, Ryan and Matt won \$10,000 in seed funding and intellectual property, legal, and accounting services to help launch their company.

Business students Jeanne Agcaoili and Alexander Santamaria created a web service specifically aimed towards students called Texbookhouse.com. The service is a response to rising book prices and provides students an easy way to buy, sell and trade books with other students on their campus. Their presentation was well done and complete with a full demonstration of how the website can be used.

Finally, team Goenzip, Andrew Esguerra, Staci Korff, Rawan Sawalha and Jasper Zheng, created an apparel line that focused on dialysis patients and that would make it easier for nurse practitioners to access a patient's bloodstream through a zipper on the garment. Team leader Andrew had witnessed the need for this innovation first hand when he was visiting his aunt, who is a dialysis nurse.

Although there could be only one winner, all of the teams have great potential to pursue their ventures in the near future. The room was filled with local business leaders and even venture capitalists, so hopefully the teams will keep working on their business and will be able to create profitable businesses.

Over 575 people attended the Leading the Ethical Organization breakfast seminar on March 29th at the Hyatt Regency Long Beach. Designed to equip business leaders with practical tools to address ethical challenges, the seminar was offered by the Ukleja Center for Ethical Leadership in partnership with the Long Beach Area Chamber of Commerce. Pat Haden, Director of Athletics at the University of Southern California, was the featured speaker and his speech was entitled "Where do we go from here?"
