Subject: 2018-2019 Academic Year Annual Report of the Academic Appeals Committee

The Academic Appeals Committee met twice monthly during the 2018-2019 year. During the year, the committee reviewed 756 appeals. The number of appeals is up from the 2017-2018 year (672 appeals), but still much lower than the 2016-2017 year.

The largest category of appeals was disqualification (42%) and reinstatement (32%). The next largest category was GE substitution (12%). The remainder of the appeals were for repeat/delete (4%), withdrawals/records problems (3%), graduation requirements (3%), and academic renewal (1%).

The number of disqualification appeals for 2018-2019 was 317, up from 284 in 2017-2018. Appeals related to disqualification were more successful, with 42% approved in 2018-2019 and 33% approved in 2017-2018. As far as reinstatement, the committee saw 242 appeals in 2018-2019, down from 318 in 2017-2018. Success rates for reinstatement appeals was 32%, down slightly from 37% in 2017-2018.

While the distribution of appeals in the different categories is similar to the previous academic year, the summary shows a decrease in the total number of appeals from the previous year. 2018-2019 saw 756 total appeals, 441 of which were granted, 205 of which were denied, and 110 were pending or no action was taken. This is up from 2017-2018, which saw 849 appeals, with 499 granted, 260 denied, and 85 were pending or no action was taken. The percentage of appeals granted remained the same, 58% in 2017-2018 and 2018-2019.

The busiest month for appeals was January, when a sub-committee reviewed reinstatement appeals from the Fall 2018 terms. The month with the fewest appeals was April, with only 9 appeals.




Figure 1: Breakdown of Appeals by Category
