# Annual Report of the Curriculum and Educational Policies Council AY 2018-2019

#### **Preface**

Many of CEPC's meetings during this academic year were devoted to the discussion and development of the General Education (GE) and Campus-Specific Graduation Requirements (GR) documents. The council started by discussing the GEGR document drafted by a summer ad-hoc committee. That document was soon replaced by a new version, which included input from a new ad-hoc committee, with representatives from all colleges.

On November 11, 2018, CEPC voted to break the document in two – one dedicated to the GE, another to GR. Following that decision, CEPC finished its review and made its recommendations on GE to the Senate at the end of its last meeting for fall 2018, meeting a deadline set by the Senate. Consequently, CEPC commenced its review of the GR document. The council finished its review and made its recommendations on GR to the Senate on March 2019, meeting a deadline set by the Senate.

Throughout the year, nonetheless, as listed below, the council still reviewed a number of other items including, for example, other policies and also new degrees. Following directions from Senate Exec, degree-related requests were given priority, so that those requests could be reviewed by the Senate at large, once the University Resources Council (URC) had also reviewed it.

#### **Unfinished Business**

- 1. Revisions to the Policy on Honors for Undergraduate Students, Policy Statement 14-08. It's been brought to the attention of the Senate and, consequently, CEPC that CSULB has the highest standards of all CSUs for Latin Honors. The request originally came from a student, who formally requested that the University revises their policy, better aligning with other CSUs;
- 2. Revisions to the Graduate Writing Assessment Requirements (GWAR) Policy, Policy Statement 12-12. CEPC was directed by Senate chair not to review such policy until the Senate is done voting on the (Campus-Specific) Graduation Requirements (GR) document.
- 3. Review of a new Master of Science in Sustainability Management and Policy. After CEPC received the proposal, concerns were raised by URC, CEPC and the Senate that the multi-college proposal had not been reviewed by any of the college curriculum committees. Senate Exec directed the responsible parties to receive approval from each college committee before it is reviewed by CEPC and others.

#### **Concerns / Queries / Comments / Recommendations**

- 1. In 2018-19, the Council had to move from its long-standing, more central meeting location, in BH-302, to the more peripheral Anatol Center. While not as conducive to meetings, CEPC appreciates the installation of a second screen and projector in the Anatol Center following a request from CEPC, and the new default configuration of tables (in a "roundtable" format).
- 2. CEPC started using BeachBoard for the first time this academic year. We recommend that the council continuous to do use the current Learning Management System in place in the future to archive council documents, including agendas, minutes and other relevant documents. This allows easier access to materials to current members, and also continuously creates an archive of past proposals (unavailable until now), which assist with decision and research. Chairs, however, are encouraged to also email the files directly to council members, better encouraging participation and awareness. Moreover, chairs should make sure the Academic Senate Office has access to agendas and minutes, as to allow them to post those on their own website, either by emailing them to the Senate, or by granting Senate staff with access to the BeachBoard group.
- 3. In preparation for 2019-20, while inviting attendees to its organizational meeting, CEPC had problems receiving a list of new, incoming members for the new year from some colleges. Some colleges had set their election deadlines past the date of the meeting itself, for example. CEPC recommends the Senate work with all colleges to ensure proper deadlines and procedures, so that all colleges are fully represented in this important meeting, and CEPC as fully staffed as possible in the following year.
- 4. The chair of CEPC also recommends the Senate consider organizing workshops to new council and committee chairs, where it could offer tips on proper procedure in council and committees, interaction between committees, councils and the Senate, tips on Robert's Rules, as well as familiarizing chairs with relevant CSULB policy that plays an important rule when running meetings on campus.
- 5. CEPC would like to thank all council members who volunteered to serve in the many council ad-hoc committees throughout the year. During a year when most CEPC meetings were devoted to GE and GR, the work of the members of these councils was vital;
- 6. The chair of CEPC would like to personally thank the vice chair and the secretary of CEPC as well as the vice provost for their continuous work and input as part of the CEP Steering Committee. The chair recommends that the CEP Steering Committee continues to meet on a regular basis in the future.
