- 1. Agenda approved as amended.
- 2. Approval of minutes from 2019-20 Meeting 12, from April 22, 2020, with edits.
- 3. Announcements
 - a. Minor in health humanities approved
 - b. Linguistics BA with option in translation studies approved
- 4. Approval of General Education Supplement #88
 - a. GEGC is still on a sort of moratorium. Only certain kinds of classes can be approved.
 - b. Nim: Effective date says Fall 2020, but we were told it wouldn't be effective until Spring 2021. Should be Spring 2021, as students are already signing up for Fall classes.
 - c. Nim: Is there a way to give people retroactive credit for taking these courses? Tiffini: No. Jody (via chat): No.
 - d. Tiffini: Are students being held to the 2019 catalog pattern yet? Jody: In the fall they will be.
 - e. Danny is changing "category" to "area"
 - f. Danny is updating the effective date to Spring 2021.
 - g. M/S/P
- 5. Revising current Policy on Cheating and Plagiarism (PS 08-02) Second Reading
 - a. Line 85 4.6 "makes a documented effort"
 - b. Proofreading type edits can be sent to Danny directly.



- c. 5.1.1 change VP of Academic Affairs to include "Provost and Senior....or designee" wherever it appears. That role "convenes," does not "appoint." M/S/P.
- d. 5.1.2 Remove line "AIC shall make readily available..."
- e. 5.2.2-3: Language about reviewing students, change to reviewing students' "case(s)" Passes, no objections.
- f. 6.1: Add "appropriate" to "Grade Appeals Committee", now should not be capitalized.
- g. 6.1 line 167: change "cheating plagiarism" to "cheating or plagiarism."
- h. 6.1: Let's not limit it to grade reductions to zero, and include any grade reductions. Mirror the language in 4.6.
- i. 6.1.1 and 6.1.1.1 Proofreading changes.
- j. 6.X Ryan's amendment about repeat/deletes. Good amendment, but perhaps it doesn't belong in this section. We will address the question with Donna, rather than passing the amendment.
- k. Ryan. Delete 6.2, as it is covered in PS 11-09. Passed no objections.
- I. Entire document approved to move on to the Senate, with copyediting.
