- 6. Announcements from Chair Paskin:
 - a. Senate started reviewing a few matters CEPC previously recommended, including two degrees and Policy on Final Course Grading. Will hold second readings in next meeting.

- 8. New proposed Graduate Certificate in Translation Studies Second Reading
 - a. Concern brought to chair from chair of URC: "the broadness of the course offerings does not appear to align to the narrowness of the proposal and the low units for the master's certificate." Donato explained issue was already discussed in URC, but explained rationale of offerings nonetheless.
 - b. Donato, Nayak and Joshee commented on benefits and financial aspect of this project.
 - c. CEPC recommended certificate to Senate by unanimous vote.
- 9. New proposed Policy on Institutional Assessment and Program Review from broader "Assessment Package" Second Reading
 - a. Comments made regarding the language of item number 1.1.2 and changing it from specific groups to a broader, general demographic. M/S/P Motion to use broader inclusive language throughout document.
 - b. Language also changed in 1.1.3.
 - c. Discussion ensued, following prompt from chair of PARC (submitted prior to meeting), on whether an entry defining "Institutional Assessment" should be added under section 1.3. Council agrees in principle, and language should be proposed in near future for discussion.
