- 1. Meeting called to order at 2:07pm
- 2. M/S/P Approval of agenda as amended
- 3. M/S/P Approval of minutes from October 27th, 2021 meeting
- 4. Announcements from Chair Paskin:
 - a. Academic Senate has approved a revised Policy on Final Course Grades, and will move on to revise the Policy on Withdrawals
 - b. Next CEPC is December 8th, 2021
- 5. M/S/P Approval of new proposed Minor in Nutrition
- 6. M/S/P Elevation of existing B.A. in Recreation, Option in Recreation Therapy to new B.S. in Recreation Therapy
- 7. M/S/P Discontinuance of M.S. in Science Education, Option in Secondary Science Education
 - a. The Science Education Department previously voted to merge the Elementary/Middle Science Education and Secondary Science Education options together into the TK-12 Option, making the singular Option in Secondary Science Education obsolete.
 - b. No students' courses of study are affected.



- c. M/S/P Process to second reading of Discontinuance of M.S. in Science Education, Option in Secondary Science Education
- 8. M/S/P New proposed Policy on Institutional Assessment and Program Review
 - a. Policy revised to recognize that external review and program review process will continue without self-study if a program does not meet a (previously requested) extended deadline.
 - b. Barnes, Cormack, and Marayong clarified Section 5.4.1 to specify the inclusion of an analysis of assessment and assessment-related data.
 - c. Barnes clarifies a reference to College Deans in Section 5.5.1
 - d. Mira and Macaulay suggest grammatical amendment to Section 6.0 Institutional Assessment; Barnes offers clarifications for Section 6.1 and Section 6.1.4.
- 9. Revision of Charge for the Institutional Assessment and Program Review Second Reading
 - a. Barnes recommends amendment to scope of council charge.
 - b. Paskin presents two options for the first item dictating the membership of IPAC and invites conversation; discussion ensues among Barnes, Cormack, Kahn, Macaulay, Marayong, Mirza, and others.
