- 7. MSP for second reading of proposals for Elevation of BA in Family and Consumer Sciences with option in Fashion Design to BA in Fashion Design **and** Elevation of BA in Family and Consumer Sciences with option in Fashion Merchandising to BA in Fashion Merchandise
 - a. Suzanne Marshall spoke to the proposals.
 - b. MSP to approve the proposals and send them to the Academic Senate.

- 8. MSP for first reading of Revision of PS 19-08, Policy on General Education.
 - a. Paskin explained that as a result of Assembly Bill 1460, the Chancellor's Office has required that all campuses add three units of Ethnic Studies to their GE programs. The Academic Senate has given CEPC three sessions to do so.
 - b. Cormack explained the need to move quickly citing the fact that students need to register for fall 2021
 - c. MSP to waive first reading.
 - d. Paskin will seek clarification on whether or not "ethnic studies" should be capitalized or not.
 - e. Discussion ensued on the three category D sections and the possibility of moving area D1 to C3.
 - f. MS to move area D1 to C3: discussion ensued.
 - g. Paskin suggested waiting until next session to consider this motion and that we will vote on it first thing in the next meeting.
