- 4. GE Supplement #90 (Area F/Ethnic Studies courses) was examined.
 - a. Discussion ensued regarding whether these new LD category F courses be cross-listed with each other since they are the same course.
 - b. Cormack will investigate item a.
 - c. MSP to recommend approval of the new GE supplement to the Academic Senate.

5. New proposed Policy on Withdrawals, First Reading.

Ad Hoc Committee members Bentley, Griswold, Green, and Hayashino spoke to these key changes in the policy draft:

- a. Academic dishonesty puts a hold on any student's W request.
- b. Changes in the definition for "dangerous and compelling" reasons for a student requesting a W.
- c. Clarification of the circumstances when a WU is appropriate.
- d. Financial aid implications.
- 6. Revision of PS 12-03, Policy on Final Course Grades, Grading Procedures, and Final Assessments, Second Reading continued.
 - a. Paskin explain that the Council would come back to 1.0 (definition of course grades) after looking at rest of the policy.
 - b. Discussion started at 2.2.5 and continued through 3.00.
 - c. Cormack will be consulted at the next meeting regarding graduate course/student implications in the next portions of the policy draft
