- I. Call to Order. In attendance: Josh Palkki, Nancy de Haro, Shae Miller, Nicole Torres, Joel Gutierrez, Anna Nazarian-Peters, Hyowon Ban, Janelle Salas Chung, Jose Rivera, Lauren Jensen, Pedro Castro, Stephanie Castillo.
- II. Approval of Agenda
 - A. Sent as PDF on meeting chat.
 - B. Agenda approved.
- III. Approval of Minutes: CLGBTIQ+CC Minutes from 9/10/21 A. Approved.
- IV. Old Business
 - A. LGBTQIA+ Cultural Welcome: Wednesday, September 15
 - i. Thank you, Stephanie for representing the Committee. Stephanie mentioned that there was a big turnout, overall positive experience.
 - B. Safe Zone collaboration
 - i. Summary of meeting with safe zone. Folks on safe zone are ready for a shift within the structure and they do want to work with us to update the structure. There have been challenges in terms of leadership and there is a proposition for others to take up a leadership position within safe zone. Shae will work with whomever decides to take that up or anyone interested. Conversation about also moving some of the information about safe zone over to our committee website. Funding is currently set up via Health and Human Services.
 - C. HERI Survey
 - i. IRB Approval for focus groups; this will take place at the end of October or early November. Facilitators have already been identified and selected. May need additional assistance when it is time to analyze the data.
 - D. Affinity Group Application
 - i. Affinity Group has been approved. This is currently one group "Queer trans staff and faculty affinity group." The group encompasses the committee and TAC.

- V. New Business
 - A. Election of Committee Secretary
 - i. Josh nominates Nancy. Nancy accepts. Elected as the new secretary.
 - B. Website update/inquiry: Nicole Torres & Lauren Jensen
 - Update: Nicole started a separate webpage specific to historical timeline. Question: how much information do we want?  - i. The change has to go through the larger Academic Senate and it has to be added to their agenda.

 - 1. Keith Comments: We are a subcommittee of the Campus Climate committee, so the conversation can start by going to Neil and Ann Kinsey. Unsure if there is just a need of a memo or something different.
 - 2. Likely will have to go through two readings from academic senate.
 - iii. Motion to change current name of our committee: COMMITTEE ON LESBIAN, GAY, BISEXUAL, TRANSGENDER, INTERSEX, QUEER + CAMPUS CLIMATE (CLGBTIQ+CC)
 - 1. Approved.
 - iv. Motion to change the name to: LGBTQIA+ CCC (Campus Climate Committee)
 - v. Motion to not spell out each identity under LGBTQIA+, just leave the acronym, leave that to the committee charge and community needs.
 1. Approved
 - vi. Motion to leave the space after (+) and before the (CCC) in the acronym. 1. 12 yes, one no.
 - vii. Motion to spell out the CCC to change to LBGTQIA+ Campus Climate Committee instead of only acronym.
 - 1. Discussion: Do we need to keep the "Campus Climate Committee" portion. Because we are a sub-committee of the Campus Climate Committee, we do need to keep it.
 - 2. Approved to keep the update the name to: LBGTQIA+ Campus Climate Committee


- D. Committee Instagram account now up and running: @csulb_lgbtiq
