 - i. Update: Student Health Advisory Committee secured new funding for this purpose.
 - C. All-gender restrooms on campus
 - i. Update: the PDF Campus map is up to date.
 - ii. Restrooms that are not ADA compliant are not listed on the CSULB map. Restrooms not accessible to the public also not listed (for example, restrooms in Student Housing, but these remain available to students living on campus). Future goal: Include these restrooms with notation

about not being ADA compliant/ Not being accessible to non-CSULB housing residents.

VI. New Business

- A. Inquiry about inclusive language in campus policies
 - i. Academic Senate is looking into changing its language to be more inclusive, for example changing “freshmen” to “first year students.” Committee chair and vice chair will attend this meeting.
 - ii. Potential places to look into updating to inclusive language: Resident handbooks, First year handbook, campus wide student regulations. Long term goal: develop a structure so that colleges and faculty affairs can include this type of language in their departments.

- A. TWEC: Transgender Wellness Education Resources Coalition. Shae updated the committee on the work that TWERC is undertaking. One goal is to have a centralized website that includes resources for transgender students. This has the support of President Conoley.
- B. LGBTIQ+ Centralized website: WGSS supports hosting a website that includes resources available for students. It was discussed that there is a need to have this on campus, but one that can stand on its own, independent of an academic department. There used to be a site for this via Student Affairs, but this was removed when the websites were updated to the new format. Committee members will follow up with Student Affairs tech/webmaster about the possibility of bringing this back.
