- 17. Refrain from engaging in horseplay, bullying or pranks;
- 18. Refrain from engaging in any activity that may or will reasonably lead to bodily or psychological harm to any other Program Participant; and
- 19. Report others observed to violate this Code of Conduct to the Program Director and/or Sponsor. In the event the activity constitutes a Mandatory Reporting incident, the Chaperone shall also orally report to Police Services immediately and in writing within 24 hours of the event.
