At its annual organizational meeting, members of the council elected the following officers:

Alan Colburn (CNSM), chair; Don Haviland (CED), vice-chair; Richard Marcus (CLA), recording secretary.

FPPC meets for two hours on the first and third Friday of each month during the academic year. This year we had a one meeting hiatus in March when classes were cancelled and we moved online. Here are the council's main accomplishments:

- Amended 17-18 Policy on Employment of Graduate Students as Student Assistants, Instructional Student Assistants, Graduate Assistants, and Teaching Associates (meetings 1, 2, 3)
- Discussed whether 07-01 Student Grievance Policy should be discontinued, amended, or unchanged. The policy was also discussed in CEPC; FPPC's chair attended those meetings (meeting 4)
- Amended policy 96-09 Permanent Reassignment of Tenured or Probationary Faculty Members (meetings 5, 6)
- Extensively amended policy 17-08 Policies and Procedures for the Selection, Appointment, and Review of Academic Administrators (meetings 7, 8, 9, and 10). The Senate chair has a separate document describing our suggested amendments.

We look forward to seeing each of these policies discussed in next year's Academic Senate.

In addition to these major activities, the council also discussed issues related to whether the 2019 conflict of interest policy superseded a 1999 policy, amended slightly (we thought at the time) the University Awards Committee charge, and discussed a resolution encouraging the CSU to create an open access publication repository.

The council encourages every effort that inspires colleges to recruit eligible faculty interested in and able to serve on our collegial, productive council. We had at least one vacancy this year and last year.
