##### General Updates/Announcements:

- Title VI and Fulbright Hayes approved at same amount.

Shawna Dark, Jennifer Lars, Marvin Mayo: housed in AA and focus on instructional technology, whereas IT focuses on operational (i.e., telecom, wiring, etc.) to empower instructors and build effective content for students—BeachBoard, training, accessibility. - b. IEC and Program Review (Richard and Terrence)

Richard Marcus: It's not IEC job to review processes but to contribute from the academic side to what works and what doesn't. What are students learning and how does it fit? Whatever the learning outcomes are, they will learn it with our partners instead of with us. Need to find intersecting points of outcomes with partners and see where items fit. Example of Germany partner: economics courses taken abroad in Germany are non-quantitative. Students come back and departments are unhappy. However, Richard learned that German expectations are so high in economics that they are not allowed to take the quantitative classes. Rather than just administrative review there needs to be assessment and reconsideration with partners in order to increase numbers and better match courses.
