 - a. Maria Aceituno Any tech can be used but Academic Technology Service can only provide support through campus approved tech.
 - b. Heather Barker can we give access to Beachboard to international partners?
 - i. Sharon there is a mechanism to do this by giving them "filler" student ID numbers.
 - c. Elaine Haglund Request to Maria Aceituno to assist with providing resources on conference telecommunication in advance of meeting with fundraisers for potential expansion of COIL opportunities in the Global Studies Institute.
- v. Pei Fang if COIL is pursued as a structural approach do courses need to be re-approved through curriculum process?
 - 1. Heather Graham Currently, yes. However Heather Graham will propose to Academic Senate to include COIL as a manner of approved instruction in future curriculum approval forms.
 - 2. Generally, no. As COIL will most often be used as a learning tool or instructional activity, rather than a manner of instruction substantively different than current categories of "in person," "hybrid," or "online."
