Position: Lecturers – Part Time in the School of Social Work teaching in a variety of specialty areas such as practice, human behavior, research, administration, policy, seminars. Teaching opportunities are available in both the graduate and undergraduate programs Monday through Saturday.

Required Qualifications:

A minimum of a Master in Social Work degree from an accredited program, two or more years of post MSW work experience, and demonstrated potential for teaching at the college level. Human Service workshops and training experience may be considered as augmentation for university teaching. Candidates must have the ability to communicate and work effectively with an ethnically and culturally diverse campus community.

Preferred Qualifications:

A Master in Social Work Degree, plus a Ph.D. or D.S.W. in Social Work or a closely related field. Two or more years of fulltime equivalent teaching experience at the university level. Four or more years of post-MSW paid social work experience.

Duties:

- Teach undergraduate and/or graduate courses from departmental standard course outline, and adhere to posted student advising hours and other teaching responsibilities as specified in the faculty handbook. Mode of instruction may include in-person, hybrid, on-line, and/or any combination thereof.
- Attend one Faculty Meeting per semester
