Signature Assignment for COUN 510 (Law & Ethics) Case Study

Student Learning Outcome(s) Assessed:

SLO #1: Perform ethical decision-making model in accordance with state and federal law and professional ethical codes (including knowledge of diverse populations and counseling needs).

Description of the Signature Assignment

Candidates will analyze or assess a vignette that is appropriate to their field of study (e.g., School Counseling, SDHE, MFT). They will identify all legal and ethical issues present in the vignette and develop a plan based on current research to deal with the legal and ethical issues.

Directions for Students

You will be assigned a vignette relating to the counseling professions that contains several key legal and ethical issues. You are to address the following areas in a 4-5 page double spaced paper. Keep in mind that in these vignettes, there may be no one specific correct answer regarding how issues are to be handled, but that students must identify all significant issues and apply correct legal and ethical standards to the situation. I am looking for your knowledge and understanding of applicable laws and ethical codes, and your professional and clinical decision-making process as you describe your course of action.

FORMAT: (5 points) **Include a separate title page** (not included in the 4-5 page minimum requirement) that includes your name, the name of your program and topic of research. Make sure your paper is responsive to the prospective of your particular discipline. Use correct grammar, spelling and professional presentation. Use 12 pt. font and 1" margins.

Use the following section numbers for your paper:

- I. Identify the key legal and ethical issues in your vignette based on your particular discipline or license. Please **underline** each legal and ethical issue that you discuss in this section. (10 points)
- II. Summarize two articles or sources (other than the text) that relate to **ONE** of the issues in the vignette. Be sure to properly cite the articles or sources in your paper. Articles and sources must be from **current** professional journals. Your text or ethical codes may be cited, but do not count toward the two required sources (10 points)
- III. Develop a plan for handling the situation that includes management of all identified issues. Also discuss why and how you arrived at a particular course of action. The vignettes give basic information only, so you should indicate if there is more information you would need to assess the situation. (10 points)

- IV. Discuss possible reactions or implications for the client or student and how you would handle them. (5 points)
- V. Discuss **your own feelings and possible reactions to being the professional** in this situation with reference to countertransference issues. This should be a thoughtful, insightful discussion. (5 points)
- VI. Bibliography- In your bibliography you should properly cite all sources used for this paper. Resources will be evaluated based on their currency, relevance, and validity of source. (5 points)
