#### **Description of the Signature Assignment**

Candidates will write a case study report based on a variety of assessments they have conducted with a student. In their report, candidates will provide some background information about the student, identify the student's reading strengths and needs, identify standards from the Common Core State Standards English and Language Arts that are related to the student's needs, and describe effective instructional reading strategies and materials that would match the identified standards and address the needs of the student.

#### **Directions for Students**

- 1. Provide some background information about the case study student. The information should be supported by assessment data (e.g., an interest interview, your assessment results, and/or the assessment results from the student's classroom teacher).
- 2. Identify 2 or 3 reading strengths of the case study student. All identified strengths should be supported by data from at least one or more of the specific assessments.
- 3. Identify 2 or 3 reading needs of the case study student. All identified needs should be supported by data from at least one or more of the specific assessments.
- 4. Describe at least 2 effective instructional reading strategies and materials that would match the identified standards and address the needs of the case study student.
  - a. Identify standards from the Common Core State Standards English and Language Arts that are related to student's needs.
  - b. Describe the instructional strategies and materials.
  - c. Describe how to ensure student's active participation and how to monitor student's progress during the application of the strategies and materials.
