Signature Assignment for ETEC 540 Cataloging System Analysis

Student Learning Outcome(s) Assessed:

SLO #8: Organize collections according to standard library cataloging and classification principles.

Description of the Signature Assignment

Candidates catalog (at level 3) and classify 10 items representative of problems addressed in library professional technical services work. Each entry consists of a public access view and a basic MARC record.

Directions for Students

Cataloging: (100 points)

Using AACR2R rules, catalog 10 items representative of problems addressed in this course. Each print item must represent one of the following: fiction, nonfiction, paperback, reference, series, and periodical. Each non-print item must represent a different format: CD-ROM, video, sound, and website. One item must be bilingual or in a language other than English.

- 1. Prepare a main entry for each item including: call number, body of the record, all added entries (tracings); this would look like with the patron would see
- 2. Records may be done using an automated cataloging system, or in card format.
- 3. For ALL items, create an accompanying MARC record. These may be generated using an automated system.

Each item is worth 10 points, and is graded based on accuracy on: the form of the entry; punctuation and spacing; accuracy of main entry added entries.

Classification: (30 points)

For the 10 items catalogued (in the same forms), assign the correct

- 1. Dewey Decimal Classification (1 point per item)
- 2. Sears Subject Headings (2 points per item)
