SB 2042 PRELIMINARY SINGLE SUBJECT TEACHING CREDENTIAL

- Valid for 5 years from issue date
- What grade levels can you teach?
 - Eligible to teach grades Preschool, K-12, and adults in a departmentalized classroom
- English Learner Authorization
 - Your credential will include an English Learner Authorization
 - Code ELAS – "Single Subject"
 - Candidates adding a Bilingual Authorization receive a BASP, BAKO, BAMA or BAVI

PRELIMINARY CREDENTIAL EVALUATIONS

- Student Teaching & EDSS 473 are noted as in progress (IP) until grades have posted
- Missing items are noted as “Needs” and must be submitted prior to credential recommendation
 - CPR -front and back of signed card, or printout of certificate
 - US Constitution
 - Transcripts
- Added Authorization – respond to analyst to confirm if you want the added authorization
- CalTPAs
 - Scores will be sent directly to Long Beach State

UNIVERSITY INTERNS

- Before you apply for your credential you must make sure that all intern support hours have been submitted and approved by your mentor teacher
- In the case that you do not pass both TPA's by the end of June 2022, Jessica Olague will reach out to you about your intern status with the program

APPLYING FOR YOUR CREDENTIAL

- ❑ Step 1: Complete the Single Subject Program Survey and submit your evaluations to TPAC.
- ❑ Step 2: AFTER you have completed student teaching, passed both TPA's and completed all requirements on your evaluation, you may start the application process
 - ❑ Complete the Request for Credential Recommendation Qualtrics form and submit any missing documentation, ex: CPR, US Constitution, etc.
 - ▶ IMPORTANT - You will need to provide a non CSULB email on this form. Please ensure that you will be giving us the same email address that you have on file with the CTC
- ❑ Step 3: A CSULB Credential Analyst will do a final evaluation and submit an online recommendation on your behalf to the Commission on Teacher Credentialing.
- ❑ Step 4: You will receive an email from the CTC asking you to complete the next portion of the online application.

- ❑ Step 5: Within approximately 10 days of completing the CTC application, you will receive notification from the Commission that your document has been granted and is available for viewing in your Educator Profile
- ❑ Step 6: Print and carefully review your credential documentation. Contact the Credential Center ASAP if your document is not correct, or if you have questions

As of today, the CTC has a credential fee waiver in place for your 1st credential. The fee waiver will only be available until June 30th (or until funds run out, whichever is first).

PHYSICAL EDUCATION AND ENGLISH STUDENTS

- Effective 1/1/22 - There has been a change to the PE and English Credential Authorizations
 - Dance is no longer subsumed under Physical Education
 - Theater/Drama is no longer subsumed under English
- Candidates with a credential issue date after 1/1/2022 who need the Dance or Theater/Drama authorization will need to submit a CTC paper application and a \$100 personal check for your credential. The paper application process delays the issuance of your Preliminary Credential by approximately 60 working days.
 - Separate application instructions coming out this week to those who want the authorization. Documentation will come to the Credential Center
 - A credential analyst will send you a temporary credential verification letter while you wait for the CTC to process your credential.
- All other PE and English candidates will receive the new authorization. If you want to earn the Dance or Theater/Drama Single Subject area at a later date you must meet subject matter in that new area and take a Single Subject Pedagogy course in that subject.
 - If you have not responded to the email from Leah, please do so asap

OTHER IMPORTANT ITEMS

- Be sure to keep a personal portfolio of all test scores, evaluations, etc.
- All candidates will receive an: Individual Development Plan (IDP) at the completion of your program.
 - This document will provide recommendations for professional development and growth during your clear induction program.
 - Share this document with your Teacher Induction Program

CLEAR CREDENTIAL

- Completion of an Induction Program
 - Induction programs are offered by:
 - Districts and County Offices of Education
 - University's - but only an option if your employer does not offer induction
- When all requirements are met you apply for the Clear Credential through the Induction Program sponsor
- Clear Credentials are renewed online every five years
- It is your responsibility to renew your credential before the expiration date

FAQ'S

- What happens if I do not finish and apply for my Preliminary Credential?
 - Your Credential Center file will be put on "hold" until you complete all requirements and return to our office to apply for your credential.
 - Be aware that some requirements expire – ex: fingerprints, CSET examinations, CPR, coursework, and program standards.
- What happens if my Preliminary 5-year Credential expires?
 - You do not need to complete a new Preliminary Credential Program
 - Extensions may be available, but MAY be subject to new regulations
- I am moving out of state, can I complete induction out of state?
 - Officially the answer is "no", but if you earn another credential out of state teach on that new document you may be able to use this to help you earn your CA Clear Credential. Please contact our office for more information.

ADDING FULL AUTHORIZATIONS

- Additional Single Subject Area
 - Complete subject matter competency in area of interest AND
 - Complete additional subject specific methods course (EDSS 450)
- Multiple Subject Credential - Authorization to teach in a self-contained classroom preschool, K-12, and adults
 - Complete Elementary Subject Matter (Multiple Subject)
 - Pass RICA exam and complete an Elementary Reading Methods Course
 - Complete one additional Elementary Methods Course

SUPPLEMENTARY AUTHORIZATIONS

- Added directly to your Single Subject Credential document
- Authorizes departmentalized teaching in grades 9 and below
- Earned strictly through coursework
- Minimum of 20 semester units required – must meet specific content areas required by the CTC
- Request a free evaluation of coursework before receiving your preliminary credential - Email ced-credentials@csulb.edu to request an evaluation
 - After issuance of your Preliminary Credential, an additional fee will apply
