- Enrollment in the Master's degree program in Chemistry or Biochemistry at CSULB
- Demonstrated ability or potential to teach
- Ability to communicate effectively with an ethnically and culturally diverse campus community

### Duties

Teach chemistry in lower division classes under direct supervision. Courses may include Chem 90, 95, 100, 111A&B, 140, 223A&B, 251. Required mode of instruction may include in-person, hybrid, online, and/or any combination thereof. Teaching Associates must attend all mandatory TA training sessions and maintain good academic standing in the department.

**Note:** Graduate students must be enrolled in at least 1 unit during each semester employed unless program courses are not available or all course work (except thesis) has been completed, in which case enrollment in GS 700 is permitted. **This is university policy.**
