GENERAL REQUIREMENTS & ADMISSIONS INFORMATION

The PPSC Program is open to all students who have graduated with a BA degree from an accredited university and are enrolled in the 60-unit MSW curriculum at California State University, Long Beach. Each candidate must be a part of the Child and Family Well-being concentration and obtain a certificate of clearance from the Commission on Teacher Credentialing (CTC).

- 1. Students must attend a PPSC Orientation. Students will receive all of the information and materials related to the PPSC Program at the orientation.
- 2. The PPSC application must be submitted by the deadline.
- 3. The submission of 1-2-page double spaced personal statement must accompany the application by the announced deadline. This statement should include a student's knowledge of a school social worker's role and their reasons for pursuing the credential. The attributes they have that will assist them in preparing to be a school social worker, and how they will use this credential after graduation.
- 4. After the orientation interested students must apply online for a Certificate of Clearance with the Commission on Teacher Credentialing AS SOON AS POSSIBLE. <u>Students will not be accepted into the</u> <u>PPSC program until COC is received.</u> Please see link below for certificate of clearance instructions. <u>https://www.csulb.edu/sites/default/files/groups/credential-center/document_ced_credential-center_certificate-clearance-3-16.pdf</u>
- 5. Students must open a file with the CSULB Credentialing Center **prior to** the first day of classes in which they are entering the PPSC program with verification of having done so sent to the PPSC Coordinator.
- 6. Students must take all 3 section of the CBEST or provide proof of meeting the basic skills requirement prior to the start of their second-year field placement- Please click on link below for latest details regarding this requirement.

- a. Options for satisfying basic skills requirement:
 - Pass CBEST (students must take all three sections of CBEST)
 - Pass CSET Multiple Subjects PLUS Writing Skills Examination
 - Pass the CSU Early Assessment Program of the CSU Placement Examination
 - Achieve Qualifying Score on the SAT or ACT
 - College Board Advanced Placement (AP) Examinations
 - Pass a Basic Skills Examination from Another State
 - Coursework in reading, writing, and mathematics (see above link for more info)
 - Qualifying Coursework and Exam (see above link for more info)

- 7. Students must complete any/all health screening (i.e. T.B. test, measles vaccination, etc.) the individual schools may require prior to entry into the School Social Work field placement.
- 8. Students must successfully complete one advanced field placement experience, totaling 600 hours (typically 20 hours per week except advanced standing students), in a designated school setting; 450 hours are designated for School Social Work activities; 150 hours are designated for Child Welfare and Attendance activities. The students must be under the supervision of a MSW with a PPSC in School Social Work and Child Welfare and Attendance. Students are strongly encouraged to have experience in working with at least two different school aged populations: elementary, middle and/or high school; with students of diverse life experiences and backgrounds including students who are racially or ethnically different, sexual minority youth (LGBTQ+), special education students, homeless and foster youth and students with mental health needs.
- 9. Students must have experience in working with at least two different school aged populations: elementary, middle and/or high school; with students of diversity (at least 10 students of a racial or ethnic background that is different from your own) which include regular and special education students.
- 10. In addition, to completing the Comprehensive Skills Evaluation used for all MSW students in field placements; the field instructor will also complete the PPSC Comprehensive Skills Evaluation (mid-year and final) and the Required Activities Checklist document and submit them to the PPSC Program Coordinator.
- 11. Students must successfully complete the School Social Work class (SW665) taken either prior to or concurrently with the school social work field placement.
- 12. Students must attend four required School Social Work seminars offered in the evening during the regular academic school year. (2 in the Fall & 2 in the Spring)
- 13. Students must maintain a 3.0 GPA for all semesters (if, at any time students are on academic probation, students are no longer eligible for the program) and earn a letter grade of "B" or better in SW 665 course and successfully complete the 60-unit MSW curriculum in the Child and Family Well-being concentration at California State University, Long Beach, School of Social Work.
